PURSUANT to section 10 of the National Parks Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby declares that the lands described in the Schedule hereto, being Crown land subject to the provisions of the Land Act 1948, shall as from the date hereof be added to and form part of the Fiordland National Park, and shall hereafter be managed, administered, and dealt with by the Fiordland National Park Board in accordance with the provisions of the first-mentioned Act.

SCHEDULE

SOUTHLAND LAND DISTRICT

ALL that area in the Southland Land District, Fiord County, containing by estimation 660 acres, more or less, and bounded

as follows:

Commencing at a point on the southern shore of the South Entrance of Preservation Inlet, also known as Otago's Retreat, the said point being distant 50 chains in a straight line running north-easterly from Trig.
