#### Price Order No. 1759 (Californian and Cyprus Oranges)

# URSUANT to the Control of Prices Act 1947, the Price ribunal hereby makes the following price order:

- 1. This order may be cited as Price Order No. 1759, and nall come into force on the 5th day of December 1958.
- 2. (1) Price Order No. 1693\* is hereby revoked, and Price rder No. 1733† is also hereby revoked in so far as it applies · Cyprus oranges.
- (2) The revocation of the said orders shall not affect the ability of any person for any offence in relation thereto mmitted before the coming into force of this order.

### APPLICATION OF THIS ORDER

3. This order applies with respect to all Californian and yprus oranges sold by way of retail in New Zealand.

#### IXING MAXIMUM RETAIL PRICES OF ORANGES TO WHICH THIS ORDER APPLIES

- 4. (1) The maximum price that may be charged or received 7 any retailer for any oranges to which this order applies all be determined as follows:
- (a) With respect to oranges sold at any place within the metropolitan areas of Auckland, Wellington, Christ-church, or Dunedin, as defined in the Schedule hereto, or in any of the Cities or Boroughs of Whangarei, Hamilton, Tauranga, Gisborne, New Plymouth, Stratford, Wanganui, Palmerston North, Napier, Hastings, Blenheim, Nelson, Greymouth, Westport, Timaru, Oamaru, Gore, Balclutha, or Invercargill—

# PROVISION FOR SPECIAL PRICES

PROVISION FOR SPECIAL PRICES

5. Notwithstanding anything to the contrary in the foregoing ovisions of this order, and subject to such conditions, if any, it thinks fit, the Tribunal, on application by any retailer, by authorise special maximum prices in respect of any anges to which this order applies where special circumnoses exist, or for any reason extraordinary charges (freight otherwise) are incurred by the retailer. Any authority ren by the Tribunal under this clause may apply with spect to a specified lot or consignment of oranges or may ate generally to all oranges to which this order applies sold the retailer while the approval remains in force.

## DUTY IMPOSED ON RETAILERS

6. Every retailer who offers or exposes for sale in any shop y oranges to which this order applies shall keep in a ominent position in such proximity to the oranges to which relates as to be obviously in relation thereto, a ticket, scard, or label on which shall be stated in legible and ominent characters the words "Californian" or "Cyprus," the case may be, and the retail price per pound of the inges.
