2. The boundaries of the Edendale Rabbit District, which was constituted by Order in Council on the 17th day of December 1941,* are hereby altered and redefined; and as from the commencement of this order, the boundaries of the said district shall be those specified in the Schedule hereto.

BOUNDARIES OF THE EDENDALE RABBIT DISTRICT

ALL that area of land in the County of Southland, Southland Land District, containing by estimation 73,500 acres, more or less, inclusive of roads, railways, and streams, and bounded as
