*Boundaries of Borough of Hawera, County of Hawera, and Hawera Riding of County of Hawera Defined*

PURSUANT to section 26 of the Municipal Corporations Act 1954, the Secretary for Internal Affairs hereby defines, as set out in the Schedule hereto, the boundaries of the Borough of Hawera, the County of Hawera, and the Hawera Riding of the County of Hawera, the previous boundaries having been altered by Order in Council made on the 23rd day of December 1958, and published in *Gazette*, 15 January 1959, No. 2, page 10.

SCHEDULE

BOUNDARIES OF BOROUGH OF HAWERA

ALL that area in the Taranaki Land District bounded by a line commencing at the junction of Waihi Road and Fantham Street, being the north-western corner of Lot 3, D.P. 2320, and proceeding generally easterly and south-easterly along the southern side of Fantham Street to a point on the north-eastern boundary of part Lot 8, D.P. 1022, in line with the south-eastern side of an unnamed road crossing the Wellington - New Plymouth Railway and defined on S.O. Plan 5950; thence along a right line to and along that side to the north-eastern side of the said railway; thence south-easterly along that north-eastern side to the north-western extremity of Scott Street; thence generally north-easterly along the south-eastern boundaries of part Sections 180 and 179, Patea District, as shown on D.P. 3543, and the eastern boundary of part Section 179, Patea District, as shown on D.P. 4158, to the westernmost corner of Lot 3, D.P. 2985; thence south-easterly along the south-western boundary of the said Lot 3 and the south-western boundaries of Lots 3, 4, and 5, D.P. 7815, and Lots 5 and 6, D.P. 2985, to Tawhiti Road; thence along a right line across that road to the westernmost corner of Lot 2, D.P. 7299; thence south-easterly along the south-western boundary of Lot 2, D.P. 7299, to and south-westerly along the north-western boundary of part Lot 2, D.P. 3139; thence south-easterly along the south-western boundaries of part Lot 2, D.P. 3139, and Lots 7 and 8, D.P. 2590, to the western boundary of part Lot 1, D.P. 3399; thence southerly along the western boundaries of part Lot 1, D.P. 3399, part Lot 23, D.P. 4164, and Lot 3, D.P. 3399, to and across Ropata Street, to and southerly along the western boundary of Lot 4, D.P. 3399, to the northern side of Gladstone Street; thence easterly along the southern boundary of Lot 4, D.P. 3399, to the eastern boundary of Section 714, Patea District; thence southerly along the eastern boundary of that section and the eastern boundary of Lot 1, D.P. 5341, and its production to the northern side of High Street; thence westerly along the northern side of High Street, to and across an unnamed road to a point in line with the western boundary of Section 545, Patea District; thence southerly to and along the western boundary of that section to its south-western corner; thence along a right line across South Road to the north-western corner of Lot 1, D.P. 5148; thence south-westerly along the south-eastern boundaries of Lots 1 and 2, D.P. 6434, and generally westerly along the southern boundaries of Lot 2, D.P. 6434, and Lots 7, 6, 5, 4, and 3, D.P. 6596; thence along a right line to the south-eastern corner of Lot 2, D.P. 6596, and generally westerly along the southern boundaries of Lots 2 and 1, D.P. 6596, and the production thereof to the eastern boundary of Lot 1, D.P. 6006; thence southerly and westerly along the eastern and southern boundaries of Lot 1, D.P. 6006, and southerly along the eastern boundaries of Lot 4, D.P. 7489, and part Lot 2, D.P. 6990; thence generally southerly along the eastern boundary of Lot 1, D.P. 7222, the eastern extremity of Iredale Road and the eastern boundaries of Lots 8, 15, 16, 17, 18, 19, and 25, D.P. 7367; thence north-westerly along the south-western boundary of Lot 25, D.P. 7367, to the north-eastern corner of Lot 1, D.P. 7368; thence south-westerly along the south-eastern boundaries of Lots 1 and 5, D.P. 7368, to and north-westerly along the north-eastern side of Manawapou Road to a point in line with the south-eastern boundary of Lot 1, D.P. 6663; thence south-westerly to and along the south-eastern boundaries of Lot 1, D.P. 6663, and part Lot 3, D.P. 590; thence north-westerly along the south-western boundaries of part Lot 3, D.P. 590, and Lot 1, D.P. 6961, to and south-westerly along the south-eastern side of Fairfield Road to a point in line with the south-western boundary of Lot 71, D.P. 2149; thence north-westerly to and along the south-western boundaries of Lots 71 and 70, D.P. 2149, the extremity of Princes Street, Lot 1, D.P. 7498, and Lot 1, D.P. 6238; thence north-easterly along the north-western boundaries of Lot 1, D.P. 6238, Lot 1, D.P. 5966, and Lot 1,
