

a right line to and along the aforesaid middle line and the middle of Pokeno-Miranda Road to a point in line with a right line running through the middle of Allotment 231, Parish of Koheroa; thence along a right line to and along other right lines passing through the middle of Allotment 231 aforesaid, crossing Miranda-Pokeno Road and along the middle of the public road intersecting Lot 3, D.P. 12260, to the western boundary of Allotment 82, Parish of Koheroa in Block VI, Wharekawa Survey District; thence along the western and northern boundaries of that allotment crossing and recrossing the Miranda-New Brighton Coast Road to the shores of the Firth of Thames; thence southerly generally along the aforesaid shores to and along the left bank of the Miranda Stream to a point in line with the western boundary of Lot 2, D.P. 28111; thence along a right line across that stream to and along the aforesaid western boundary and the western boundary of Lot 1, on the said D.P. 28111, crossing the intervening Miranda-Waitakaruru Road, along the western boundary of part of Waitakaruru 4c 5, the western boundary of Waitakaruru 4c 3 and again along the western boundary of another part of 4c 5 aforesaid and part Waitakaruru 4c 4 and along the western boundary of Lot 3, D.P. 21822, to its western corner; thence along a right line being the production of the last-mentioned boundary across Sections 8 and 10, Block VIII, Wharekawa Survey District, to and along the north-eastern boundary of part Section 1, the north-eastern, eastern, and south-eastern boundaries of Section 2, both sections being of Block VIII, Wharekawa Survey District, and along the northern boundary of part Section 20, Block II, Piako Survey District to its intersection with a right line between Trig. Station No. 135 (Rataroa), and the north-western corner of Section 38, Block VII, Piako Survey District; thence along the aforesaid right line to and along the south-western boundary of the aforesaid Section 38, crossing the intervening Steens Road and the Pokeno-Paeroa State Highway and along the south-western boundaries of parts Sections 4 and 5 of the said Block VII, the south-western boundaries of part Section 12, Section 15, the abutment of a public road, Section 18, the abutment of another public road and the south-western boundaries of Sections 19 and 5, all the aforesaid sections being of Block XI, Piako Survey District, the western boundaries of part Section 1 and Section 2, Block XV, of the last-mentioned survey district, a right line across Matahuru Gorge Road to and along the generally western boundaries* of Section 9, Block XVI, Piako Survey District, Section 1s, part 3s and 12s, Tainui Settlement, the western boundaries of Hoeotainui North, part 6B 2J 1 and 5B 2, Sections 6 and 7, Block VIII, Hapuakohe Survey District, Hoeotainui North 5A North Sections 2A 2, 2A 1 and 2B, crossing the intervening Tahuna-Ohinewai Main Highway and the Mangawhara Stream, to and along the western boundaries of Lots 6 and 8, D.P. 13199, Lot 1, D.P. S. 5428, Sections 18, 17, 16, and 15, Block XII, Hapuakohe Survey District, crossing the intervening Tainui Road to and along the western boundaries of Hoeotainui South 1A 2 and 1A 1, Lot 1, D.P. 29197, Lots 4 and 3, D.P. S. 862, Lot 1, D.P. 8138, a right line across the Taupiri-Morrinsville Main Highway to and along the western boundaries of part Lot 6, D.P. 11661, Lots 1 and 2, D.P. 12366, Lots 1 and 2, D.P. 13235, Lots 5 and 6, D.P. 12470, Lot 1, D.P. 29321, Lot 1, D.P. S. 3536, Lot 2, D.P. 20628, part Lot 1, D.P. 3622, and Lot 9, D.P. 6948, along a right line across Piako Road, the Frankton-Rotorua Railway, and a public road to and along the western boundaries of Lots 1 and 2, D.P. 8165, Lot 1, D.P. 7723, a right line across the Cambridge-Eureka Main Highway to and along the western and south-western boundaries of Lot 2, and the south-western boundary of Lot 1, both lots being shown on D.P. S. 2799, along the southern boundary of part Lot 2, D.P. 7860, to and along a series of right lines passing through Lot 1, D.P. 23795, part Tahuroa Block, across Tahuroa Road and through Lot 1, D.P. S. 3993 and Lot 2, D.P.S. 3994, being along the generally southern boundaries of Lots 1 and 2 on L.T. Plan 20705, to the western corner of Lot 5, D.P. 11745; thence again southerly along the western boundary of that lot and Lots 4, 3, 2, and 1 on the aforesaid D.P. 11745, and along a right line being the production of the last-mentioned boundary to the middle of Scotchmans Valley Road; thence along the middle of that road to a point in line with the south-western boundary of Lot 2, D.P. 15442; thence along a right line to and along the aforesaid south-western boundary, the southern boundaries of section 7, Block XIV, Maungakawa Survey District, Lots 3 and 4, D.P. S. 2306, the southern boundary of part Teauowai 8 Block to and again southerly along the western boundary of Kiwitahi 2E Block, the western and southern boundaries of Kiwitahi 2D Block to and up the middle of the Topehahae Stream to a point in line with the southern boundary of Kiwitahi 1D 1 Block; thence along a right line to and along that southern boundary crossing the intervening Hautapu-Te Miro Road, to and along the western boundary of Section 5, Block III, Cambridge Survey District, to and south-westerly along the north-western boundaries of part Lot 43, D.P. 14557, part Lot J, D.P. 2756, crossing the intervening Whitehall-Te Miro Road, Lots 1 and 2, D.P. 22079, a right line across Whitehall Road to and along the north-western boundaries of Lot 1, D.P. S. 2875, part Section E 2 and Section W 2, Whitehall Settlement, along a right line being the production of the last-mentioned boundary across a public road to and along the north-western and western boundaries of part Hinuera 2 Block, the north-

western boundary of Section 15, Karapiro Settlement, to and along the eastern boundary of part Lot 2, D.P. 3569, a right line across French Pass Road to and along the western boundary of part Section 9, Karapiro Settlement and a right line being that boundary produced to the middle of the Karapiro Stream in Block X, Cambridge Survey District, thence westerly down the middle of that stream to and along the eastern, northern, and western boundaries of the Borough of Cambridge as described in *Gazette*, 1958, page 1732, to and down the middle of the Waikato River to the southern boundary of the City of Hamilton; thence northerly generally along the eastern and northern boundaries of the City of Hamilton as hereinbefore described and again down the middle of the Waikato River aforesaid to and along the south-eastern, north-eastern, and northern boundaries of the Borough of Ngaruawahia as described in *Gazette*, 1921, page 501, to and again down the middle of the Waikato River to and along the southern, eastern, and northern boundaries of the Borough of Huntly as described in *Gazette*, 1948, pages 1107 and 1108, and again down the middle of the Waikato River to and down the middle of the channel between Allotments 10 (Taipouri Island) and 11 (Motukorea Island), Parish of Whangape, and continuing down the middle of the Waikato River so as to include all the islands in the said river, to the point of commencement.

BOUNDARIES OF HUNTLY RIDING

All that area in the South Auckland Land District, bounded by a line commencing at a point in the middle of the Waikato River in Block III, Rangiriri Survey District, due west of the middle of the mouth of the Oneteca Stream, and proceeding easterly generally along a right line to and up the middle of the aforesaid stream to a point in line with the western shore of Lake Waikare; thence along a right line across that lake to and along the northern and eastern boundaries of Allotment 212, Parish of Whangamarino, crossing the intervening Waikare Lake Road, to and along the northern boundaries of Section 1, Block I, Hapuakohe Survey District, Allotments 665 and 670, and northern and eastern boundaries of Allotment 671, to and along the northern boundary of part Allotment 269, and along a right line across the Waerenga-Pukewhau Road to the western corner of Allotment 659, all the aforesaid allotments being of the Parish of Whangamarino; thence southerly along the eastern side of that road to and again easterly up the middle of the Matahuru Stream to a point in line with the western boundary of Allotment 472; thence along a right line to and along the western and northern boundaries of that allotment and the north-western boundaries of Allotments 448, 449, 450, 451, 452, 453, and 454, all the aforesaid allotments being of the Parish of Whangamarino, to the eastern boundary of the County of Waikato; thence southerly generally along that county boundary hereinbefore described to its intersection in Block XII, Hapuakohe Survey District, with the production of a right line from the eastern corner of Allotment 639, Parish of Taupiri, and passing through the southern corner of Allotment 435B of the said parish; thence south-westerly generally along that right line to the aforesaid eastern corner and south-easterly along the south-western side of Proctors Road to and again south-westerly down the middle of the Mangawara Stream to the middle of the Waikato River; thence northerly down the middle of that river to and along the southern, eastern, and northern boundaries of the Borough of Huntly as described in *Gazette*, 1948, pages 1107 and 1108, to and again down the middle of the Waikato River, down the middle of the channel between Allotments 10 (Taipouri Island) and 11 (Motukorea Island), Parish of Whangape, and again down the middle of the aforesaid river to the point of commencement.

BOUNDARIES OF RUAKURA RIDING

All that area in the South Auckland Land District, County of Waikato, bounded by a line commencing at the south-eastern corner of Lot 5, D.P. 12436 in Block IV, Komakorau Survey District, on the eastern boundary of the County of Waikato, thence southerly generally along that county boundary as hereinbefore described, to and along the south-western boundaries of Tahuroa 4 and 3 Blocks to the northern side of Griffins Road; thence westerly generally along the northern side of that road to and along a right line across part Lot 18, D.P. 25846, the Tauhei-Motumaoho Road and Lot 2, D.P. 17019, to an angle in the last-mentioned lot, the said right line being shown on those plans as the boundary between Tamahere and Kirikiriroa Parishes; thence along a right line to the south-eastern corner of Lot 6, D.P. 9815; thence along the south-eastern boundaries of Lots 6 and 7, D.P. 9815, and along another right line to the northernmost corner of Lot 3, D.P. 10268 in Block XV, Komakorau Survey District; thence along the south-eastern side of Collins Road and its production across the Hamilton-Paeroa State Highway, to and along the north-eastern and north-western boundaries of Allotment 244, Parish of Tamahere, and that last-mentioned boundary produced to and down the middle of the Mangaonua Stream to the right bank of the Waikato River; thence northerly generally along the aforesaid right bank to and along the generally eastern boundary of the City of Hamilton as hereinbefore described, to and along the middle of Peachgrove and Hukanui Roads to a point in line with the north-western boundary of the land shown on S.O. Plan 39234, being part Lot 1, D.P. 14662; thence easterly along a right line to and along that north-western boundary and the north-western boundaries of Lot 2, D.P. 32304, and Lot 1, D.P. 3211, and the last-mentioned boundary produced to the eastern side of the Hamilton-Tauhei Main Highway No. 534 (Tramway
