ORDER

1. (1) This order may be cited as the Tokirima Rabbit District Order 1959.

(2) This order shall come into force on the day after the date of its notification in the Gazette.

2. The boundaries of the Tokirima Rabbit District, which was constituted by Order in Council on the 17th day of December 1952,* are hereby altered and redefined and, as from the commencement of this order, the boundaries of the said district shall be those specified in the Schedule hereto.

NASH PRESIDING IN COUNCIL PURSUANT to the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby grants to Percy Evan Kelland, of Omarama, sheep farmer (hereinafter referred to as the licensee), a licence, subject to the conditions hereinafter set forth, to take and use from Exhibition Creek (hereinafter referred to as the said stream) situated in Run 546, Ohau River Survey District, in the County of Waitaki, for the purpose hereinafter set forth, a stream of water not exceeding one cubic foot per second, at any one time.
