

*Extending a 30 Miles Per Hour Speed Limit*

PURSUANT to the Transport Act 1949, the Minister of Transport hereby gives notice as follows:

1. So much of the Warrant under section 3 of the Motor Vehicles Amendment Act 1936, dated the 13th day of October 1938,\* as relates to the Piopio-Ohura via Aria Main Highway No. 870 at Piopio in Waitomo County referred to in the said Warrant as the Piopio-Tatu Main Highway is hereby revoked.

2. The road specified in the Schedule to this notice is hereby declared to be a closely populated locality for the purposes of section 36 of the Transport Act 1949.
