A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken for a microwave radio repeater station, and that an easement of right of way is hereby taken over the land described in the Second, Third, and Fourth Schedules hereto, vesting in Her Majesty the Queen, firstly, full and free liberty, right, licence, and authority in perpetuity to construct and use a right of way, with the right for Her Majesty's servants, agents, and workmen from time to

time and at all times hereafter to go, pass, and repass, with or without horses or other animals or vehicles, over the land described in the Second and Third Schedules hereto, and to maintain, repair, and keep open the said right of way and, secondly, the full and free liberty, right, licence, and authority in common with other person or persons entitled thereto in perpetuity to use a right of way with the right for Her Majesty's servants, agents, and workmen from time to time and at all times hereafter to go, pass, and repass, with or without horses or other animals or vehicles, over the land described in the Fourth Schedule hereto, and to maintain, repair, and keep open the said right of way, such easement to be held appurtenant to the land described in the First Schedule hereto; and I also declare that this Proclamation shall take effect on and after the 27th day of July 1959.
