At a special general meeting of the Hawke's Bay Hunt (Inc.) held on the 10th day of June 1959 at 2.30 p.m., it was duly resolved as follows:

"In pursuance and exercise of the powers under section 33 of the Gaming Act 1908, it is hereby resolved that the regu-lations dated the 30th day of November 1922 are hereby revoked, and in lieu thereof the following regulations shall be regulations under the said section 33 controlling the admis-sion of persons to that part of the racecourse situated in the City of Hastings and known as the Hastings Racecourse or to any other racecourse used or occupied by the club for race meetings."

HAWKE'S BAY HUNT (INC.) REGULATIONS (Under the Gaming Act 1908)

1. These regulations shall come into force on the date of the same being published in the *Gazette*. 2. In these regulations the words "bookmaker," "racing club," and "race meeting" shall have the meanings ascribed to those terms respectively by section 2 of the Gaming Act

1908. 3. The following persons shall be and are hereby excluded from the racecourse above described or any other racecourse while the same is used or occupied by the said club for a race meeting, namely:

 (e) Professional tipsters, persons convicted of house breaking, burglary, or pocket picking, forgery, uttering or possessing counterfeit coin, theft, false pretences, receiving stolen goods, mischief, assault, or any offence or crime of any kind under the Police Offences Act 1908, and persons convicted under the Police Offences
- - 1908, and persons convicted under the Police Offences Act 1927 of conversion or attempted conversion of a motorcar or other vehicle or of being idle and dis-orderly persons or of being a rogue and vagabond and persons convicted of an offence under the Gaming Act 1908, or persons hoving a grimping record in Act 1908, or persons having a criminal record in countries outside New Zealand and the references to the foregoing Acts shall be deemed to apply to any subsequent Act consolidating or in substitution therefor.

Provided always that the Executive Committee appointed by the New Zealand Racing Conference, upon being satisfied by evidence as to the character and otherwise that any person who, by reason of any conviction, comes within the scope of this regulation should have relief from the effect thereof, may grant exemption to any such person, and may at any time revoke any such exemption without notice to such person, and without assigning any reason for such revocation.
