PURSUANT to section 186 of the Municipal Corporations Act 1954 and section 125 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby authorises the Gore Borough Council to permit the laying off of Cubbin Street described in the Schedule hereto at a width of less than 66 ft, but not less than 40 ft, subject to the condition that no building or part of a building shall at any time be erected on the land shown edged green on the plan marked P.W.D. 161181 referred to in the said Schedule within a distance of 35 ft from the centre line of the said street.

*The Oakura Cemetery Order 1960*

PURSUANT to the Cemeteries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Oakura Cemetery Order 1960.
- (2) This order shall come into force on the 1st day of April 1960.

B

2. The Taranaki County Council is hereby appointed to be the trustee of the Oakura Cemetery, being the area described in the Schedule hereto, and shall have control and management of that cemetery under and for the purposes of the Cemeteries Act 1908.

3. (1) The delegation to the Taranaki County Council of the powers of appointing and removing trustees of the said cemetery made by Order in Council dated the 18th day of September 1933\* is hereby revoked.

(2) The said Order in Council is hereby accordingly amended by omitting from the second column of the Schedule the word "Oakura" where it appears opposite the reference to the Taranaki County Council in the first column of that Schedule.

*Exempting Land in the South Auckland Land District from the Operation of Part III of the Coal Mines Act 1925*

*Exempting Land in the South Auckland Land District from the Operation of Part III of the Coal Mines Act 1925 and Declaring it to be Crown Land*

NOTICE

1. The land described in the Schedule hereto is hereby exempted from the operation of Part III of the Coal Mines Act 1925.

2. The said land is hereby declared to be Crown land subject to the Land Act 1948.
