SPECIAL ORDER—CONSOLIDATED SPECIAL RATE

PURSUANT to the powers vested in it by section 108A of the Municipal Corporations Act 1954, the Invercargill City Council hereby makes a consolidated special rate of nine pence and decimal three nine nine of a penny (9.399d.) in the pound on the rateable value (on the basis of the unimproved value) of all rateable property within the City of Invercargill, and such consolidated special rate shall be an annually recurring rate and shall be in lieu of the following special rates:

Loan No. 24, 1957, £2,500,000; 4th Issue £433,000

The Auckland Metropolitan Drainage Board, in exercise of the powers vested in it in that behalf by the Auckland Metropolitan Drainage Act 1944, and in pursuance of the authority conferred on it under the Local Authorities Loans Act 1956, and their respective amendments, and in exercise of all other powers enabling it in that behalf, doth hereby resolve by special resolution, intended to operate as a special order, to borrow the sum of £433,000 (four hundred and thirty-three thousand pounds) to be designated Loan No. 24, 1957, £2,500,000, 4th issue £433,000, to be applied for the purpose of erecting treatment works and the purchase and installation of equipment incidental thereto.

The foregoing special order was made by way of a special resolution passed at a meeting of the Auckland Metropolitan Drainage Board and held on the 3rd day of February 1960. It was publicly notified in the *Auckland Star* and the *New Zealand Herald* on the 13th and 27th days of February 1960.
