

proceeding southerly generally along the middle of that railway to the line of mean high water on the right bank of the Tamaki River; thence northerly generally along that line of mean high water, to East Tamaki Head (Musick Point); thence south-easterly generally along the shores of the Hauraki Gulf to the mouth of the Puwhenua Stream; thence westerly generally up the middle of that stream to a point in line with the northern boundary of Wharekawa No. 5c Block, and along a right line to and along that boundary and along the northern boundaries of Wharekawa 5b North No. 8, 5b North No. 2, and 5b North No. 1 Blocks, and northerly along the eastern boundaries of Allotments 102 and 148, Otau Parish, the south-eastern and north-eastern boundaries of Lot 1, D.P. 29892, to and along the northern side of a public road forming the generally southern and south-eastern boundaries of Allotments 95 and 96, to and along the southern boundary of Allotment 96, along a right line being the last-mentioned boundary produced across a public road, to its western side; thence southerly along that western side to and westerly generally along the north-eastern and north-western boundaries of Allotment 89, the northern boundaries of Lot 2 of Allotment 90, and part Allotment 67, the aforesaid allotments being of Otau Parish, the eastern and northern boundaries of Lot 2, D.P. 33851, and along a right line being the last-mentioned boundary produced to the middle of the Wairoa River; thence northerly down the middle of that river to a point in line with the northern boundary of Allotment 112A; thence westerly generally along a right line to and along that boundary and the northern boundary of Allotment 112, and its production to the middle of the public road forming the western boundary of the aforesaid Allotment 112; thence along the middle of that road to and along the middle of the public road forming the north-western boundaries of Allotments 148, 149, 150, 151, 175A, S. 175 and N.W. 176, the western boundaries of Allotments M. 176 and N.W. 176 and the northern boundary of Allotment 177, all the aforesaid allotments being of Hunua Parish, to the road reserve shown on S.O. Plan 14113; thence along a right line across that road reserve to the intersection of the western boundary of that reserve with the right bank of Hay's Creek; thence down that right bank, to and along the north-eastern boundary of Allotment 168, Hunua Parish, and along a right line being the last-mentioned boundary produced to the middle of the public road forming the north-western boundary of the said Allotment 168; thence along the middle of that road, and a right line being its production to the north-eastern boundary of Lot 3, D.P. 15356; thence along that north-eastern boundary to and along the north-eastern boundaries of Allotments 150, 151, 149, 148, and 147, and the north-eastern and north-western boundaries of Allotment 146, to and along the northern end of a closed road, the north-western side of the public road forming the north-western boundaries of Allotments 145 and 144, along the north-western boundary of the land shown on D.P. 26233, and along the northern end of a public road, and the north-western boundary of Allotment 116, all the aforesaid Allotments being of Opaheke Parish, along a right line across Dominion Road, to and along the south-eastern boundary of part Allotment 27, Hunua Parish, to a point in line with the western boundary of Lot 3, D.P. 17674; thence northerly generally along a right line, passing through Allotment 27, and crossing Clevedon Road, to and along that western boundary, along a right line across the Old Wairoa Road, to and along the eastern boundary of Lot 26, D.P. 44515, and along the production of that eastern boundary to a point in line with the northern boundary of Lot 1, D.P. 44515; thence along a right line to and along that northern boundary, along a right line across Cosgrave Road to and along the north-western boundaries of Lots 34 and 14, D.P. 34538, Lots 3 and 1, D.P. 39975, and Lot 1, D.P. 34538, and along a right line crossing Grove Road, and passing through Lot 7, D.P. 43137, Lots 5, 4, 3, 2, and 1, D.P. 45330, and part Allotment 42, Papakura Parish, to a point on the south-western boundary of that allotment, 800 links distant from the northern side of the Old Wairoa Road; thence north-westerly along that south-western boundary, to and westerly along the south-eastern boundaries of parts Allotment 41, taken for Defence Purposes in *Gazettes*, 1940, page 1853, as shown on S.O. Plan 30987, and 1952, page 1989, as shown on D.P. 10783, along a right line crossing Valley Road, Lot 2, D.P. 19347, and the North Island Main Trunk Railway to a point on the western side of that railway, 77 links from the south-eastern corner of Trentham Avenue; thence northerly along that western side, to and westerly along the middle of Waterview Road to a point in line with the eastern side of Tironui Road; thence along a right line across that road, to the south-eastern corner of part Allotment 4, Section 12, Village of Papakura; thence along the south-eastern boundary of that allotment, crossing the Auckland-Hamilton State Highway, to the line of mean high water (spring tide) of the Pahurehure Inlet of the Manukau Harbour; thence northerly generally along the line of mean high water (spring tide) on the eastern shores of that harbour to a point in line with the northern side of Portage Road; thence along a right line to the point of commencement; including Wiroa, Puketutu, and other adjacent islands within the Manukau Harbour, and excepting thereout the Borough of Howick, the Borough of Manurewa, and the Borough of Papatoetoe as hereinbefore described.

BOUNDARIES OF PAPATOETOE RIDING

All that area in the North Auckland Land District bounded by a line commencing at the junction of the right bank of the Tamaki River and the left bank of the Pakuranga Creek,

in Block VI, Otahuhu Survey District, and proceeding easterly generally along the left bank of the Pakuranga Creek, to and along the southern boundary of the Pakuranga Riding as hereinbefore described to the middle of the Maungamaungaroa Creek, at the south-eastern corner of part Allotment 235, Pakuranga Parish; thence southerly generally up the middle of that creek, to and along the north-eastern side of a public road forming the south-western boundaries of Allotments 267, 272, and 274, to and along the eastern boundary of the last-mentioned allotment, to and along the southern boundary of part Allotment 117, to the public road forming the northern boundary of Lot 7, D.P. 4431; thence westerly along the northern side of that road to a point in line with the south-western boundary of the said Lot 7; thence southerly along a right line to and along that south-western boundary, and the south-western boundary of Lot 8, D.P. 4431, to and along the north-western and western boundaries of part Allotment 178, the west boundary of Allotment 177, the northern, western, and southern boundaries of Allotment 138, all the aforesaid allotments being of the Parish of Pakuranga, and along the western boundary of Allotment 153, Parish of Manurewa, to and westerly generally along the northern boundary of the Papakura Riding as hereinafter described, along the northern boundary of the Borough of Manurewa as hereinbefore described, and again along the northern boundary of the Papakura Riding as hereinafter described, to the line of mean high water (spring tide) of the Manukau Harbour; thence northerly generally along the lines of mean high water of that harbour and of the Pukaki and Waokauri Creeks, to a point in Block X, Otahuhu Survey District, in line with the eastern side of the public road forming the eastern boundary of Allotment 52; thence along a right line to and along that eastern side, along the south-eastern sides of the public road forming the south-eastern boundary of Allotment 56, Parish of Manurewa, the southern and south-eastern sides of Portage Road, the western, southern, eastern, and northern boundaries of the Borough of Papatoetoe as hereinbefore described, and along the right bank of the Tamaki River to the point of commencement.

BOUNDARIES OF PAKAKURA RIDING

All that area in the North Auckland Land District, bounded by a line commencing at a point on the line of mean high water (spring tide) on the left bank of the Puhinui Creek in the middle of the western end of Browns Road, in Block XIII, Otahuhu Survey District, and proceeding north-easterly along the middle of Browns Road, to and southerly, easterly, and then northerly along the western, southern, and eastern boundaries of the Borough of Manurewa as hereinbefore described, to and easterly along the middle of Orams Road to its eastern end on the south-western boundary of Lot 4, D.P. 31549; thence northerly along that boundary and easterly generally along the northern, north-eastern, again northern boundaries of Lot 4, D.P. 31549, along the north-western and north-eastern boundaries of Lot 3, D.P. 22977, the north-eastern boundaries of Lots 4 and 5, D.P. 31549, the north-western boundaries of Lots 1 and 2, D.P. 23951, a right line across a public road, to and again along the north-western and then northern boundaries of Lot 2, D.P. 23951, the generally northern boundaries of Lot 2, D.P. 3825, the eastern boundary of Lot 5, D.P. 46004, the southern boundary of Lot 2, the south-eastern and eastern boundaries of Lot 3, D.P. 41583, the southern and south-eastern boundaries of Lot 1, D.P. 28732, along the southern side of the public road forming the generally southern and south-eastern boundaries of Lot 3, D.P. 16511, the north-western and north-eastern boundaries of Lot 1, D.P. 24865, the north-eastern boundary of part Clendons Grant as shown on D.P. 515, and situated in Block XII, Otahuhu Survey District, to and along the eastern boundary of part Allotment 94, the southern and eastern boundaries of Allotment 91, the southern and eastern boundaries of Allotment 153, the aforesaid allotments being of the Parish of Manurewa, the southern boundary of Allotment 178, the south-eastern boundaries of Allotments 131 and 132, Parish of Pukuranga, crossing the Howick-Manurewa Main Highway, along the south-eastern and north-eastern boundaries of Allotment 33, Parish of Maraetai, to and along the southern boundaries of Allotment 55, and a right line across a public road to and along the north-western side of the public road forming the south-eastern boundary of Allotment 57, to a point in line with the southern boundary of Allotment 63; thence along a right line across that public road to and along the southern and eastern boundaries of the said Allotment 63, the eastern boundary of Allotment 61, the abutment of a public road, the eastern boundaries of Allotments 64 and 71, all the aforesaid allotments being of the Parish of Maraetai, to and along the southern boundary of Allotment 81 to its southernmost corner; thence southerly along the north-western boundary of Allotment 78, along a right line being the production of the last-mentioned boundary across the public road forming the northern boundary of Allotment 79, to the southern side of that public road; thence along that southern side to and along the north-western boundary of Allotment 47, the northern and north-western boundaries of Allotment 51, and the north-eastern side of the public road forming the south-western boundary of Allotment 50, to a point in line with the north-western boundary of Allotment 54; thence along a right line across that last-mentioned road, to and along the north-western boundary of the said Allotment 54, part of which is now included in Allotment 83, along the northern and western boundaries of Allotment 59, crossing the Brooklyn-Clevedon road, and along the northern boundary of part Allotment 24, to and
