Declaring Lands in North Auckland and Southland Land Districts, Vested in the Auckland and Southland Education Boards as Sites for Public Schools to be Vested in Her Majesty the Queen

COBHAM, Governor-General A PROCLAMATION

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto, being an area vested in the Auckland Education Board, and the land described in the Second Schedule hereto, being an area vested in the Southland Education Board, as sites for public schools shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof.

A PROCLAMATION

PURSUANT to subsection (2) of section 19 of the Forests Act 1949, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Lands and of the Minister of Forests, hereby proclaim and declare that the land described in the Schedule hereto, being portion of provisional State forest reserve set apart by Proclamation dated the 5th day of July 1920, and published in Gazette, 8 July 1920, Volume II page 2118, is required for settlement purposes; and in accordance with the provisions of the said Act such land shall, from and after the day of the gazetting hereof, cease to be provisional State forest land and shall become Crown land available for sale, lease, reservation, or other disposition under the provisions of the Land Act 1948.

A PROCLAMATION

Pursuant to subsection (2) of section 19 of the Forests Act 1949, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Lands and of the Minister of Forests, hereby proclaim and declare that the lands described in the First and Second Schedules hereto, being portions of provisional State forest reserves Nos. 1643 and 1721 set apart by Proclamations dated the 11th day of October 1920, and published in Gazette, 14 October 1920, Volume III, page 2844, and the 30th day of June 1924, and published in Gazette, 3 July 1924, Volume II, page 1579, are required for settlement purposes; and in accordance with the provisions of the said Act such lands shall, from and after the day of the gazetting hereof, cease to be provisional State forest lands and shall become Crown lands available for sale, lease, reservation, or other disposition under the provisions of the Land Act 1948.
