

middle of that river to a point in line with the north-western side of the Sallys Gully Road; thence south-westerly to and along the north-western side of that road to and generally north-westerly along the north-eastern side of Toko Mouth Road to the south-eastern boundary of Section 1 of 6, Block I, Kaitangata Survey District; thence south-westerly across the Toko Mouth Road to and along the south-eastern boundaries of Sections 1 of 6 and 2 of 6 to the southernmost corner of Section 2 of 6; thence north-westerly along the south-western boundaries of that section and Section 5 to the south-eastern boundary of Section 7, Block I, Kaitangata Survey District; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of that section and the production of that last-mentioned boundary to the south-eastern boundary of Section 3s, Tokoitii Settlement; thence generally south-westerly along the south-eastern boundary of that section and its production to the north-eastern boundary of Section 29, Block III, Kaitangata Survey District; thence generally north-westerly and south-westerly along the north-eastern boundaries of that section and Section 28 aforesaid and Section 1 to a point in line with the northern boundary of Section 38, Block II, Kaitangata Survey District; thence westerly to and along that northern boundary of Section 38 aforesaid and north-westerly along the north-eastern boundary of that section to its northernmost corner; thence south-westerly along the north-western boundaries of Section 38 aforesaid and Sections 37 and 36 to the north-eastern corner of Section 32, Block II aforesaid; thence westerly along the northern boundary of that section to Elliotvale Road; thence south-westerly along the south-eastern side of that road and its production to the north-eastern boundary of Section 9, Block V, Kaitangata Survey District; thence generally westerly along the southern side of an unnamed road to its intersection with an unnamed road through Section 3, Block V aforesaid; thence generally south-westerly along the south-eastern side of that last-mentioned road to the westernmost corner of Section 1, Block V aforesaid; thence south-easterly along the south-western boundaries of Sections 1 and 2 to a point in line with the north-western boundary of Section 10, Block V, South Tuakitoto Survey District; thence south-westerly to and generally south-westerly along the south-eastern side of Lakeside Road to the north-western boundary of Section 3, Block V aforesaid; thence south-westerly along a right line being the production of the north-western boundary of that section to the eastern shore of Lake Tuakitoto; thence generally northerly and westerly along the eastern and northern shores of that lake to a point in line with the north-eastern boundary of Section 3, Block VIII, South Tuakitoto Survey District; thence north-westerly to and along the north-eastern boundary of that section to its north-western corner; thence south-westerly along the north-western boundary of Section 3 aforesaid to the middle of Stony Creek; thence generally north-westerly up the middle of that creek to the southern boundary of Section 10A, Barnago Settlement; thence generally easterly and north-westerly along the southern and north-eastern boundaries of that section to a point in line with the western boundary of Section 25, Block VII, Hillend Survey District; thence northerly to and along that western boundary and easterly along the northern boundary of that section to its north-eastern corner; thence due north along a right line to the middle of Lovell's Creek; thence generally northerly up the middle of that creek to the southernmost corner of Lot 2, D.P. 4684; thence generally north-easterly along the south-eastern boundaries of Lot 2 aforesaid and Lot 4, D.P. 4684, to the easternmost corner of that last-mentioned lot; thence generally north-westerly along the south-western side of Mount Stuart-Lovell's Flat Road and its production to the southernmost corner of Block IV, Waitahuna East Survey District; thence generally north-easterly along the south-eastern boundary of that Survey District to Trig. Q, Round Hill; thence due north along a right line to the south-western corner of Section 28, Block VII, Table Hill Survey District; thence generally north-easterly along the north-western side of an unnamed road to a point in line with the north-eastern boundary of Section 29, Block VII, aforesaid; thence generally south-easterly to and along the south-western side of an unnamed road forming the north-eastern boundaries of the said Section 29 and Sections 72 and 91, Block IV, Table Hill Survey District, to the easternmost corner of Section 91 aforesaid; thence generally westerly along the northern side of Nugget Creek Road to the middle of Shepherds Gully Stream; thence generally south-easterly down the middle of Shepherds Gully Stream and its production to the middle of the Tokomairiro River (West Branch); thence generally north-easterly up the middle of that river to the south-eastern side of an unnamed road; thence generally north-easterly along the south-eastern side of the said unnamed road to the northernmost corner of Section 26, Block V, Table Hill Survey District; thence generally south-easterly along the south-western side of the said unnamed road and its production to the south-eastern side of Flett's Bridge Road; thence generally north-easterly along the south-eastern side of that road to the western boundary of Block VI, Table Hill Survey District; thence southerly along the western boundary of that block to the southernmost corner of Section 45, Block VI, aforesaid; thence generally easterly along the northern side of an unnamed road forming the southern boundaries of Section 45 aforesaid and Sections 40, 13, and 7 to the south-eastern corner of that last-mentioned section; thence northerly along the eastern boundary of Section 7 aforesaid to the middle of the Tokomairiro River East Branch; thence generally northerly up the middle of that river to the northern side of an unnamed road forming

the southern boundary of Section 1, Block X, Table Hill Survey District; thence along a bearing of 91° 34' to the southernmost corner of that section; thence north-easterly and south-easterly along the north-western and north-eastern sides of that unnamed road to the eastern boundary of Block X, Table Hill Survey District; thence southerly along the eastern boundary of Block X aforesaid to the southern boundary of Section 6, Block IX, Clarendon Survey District; thence easterly along that boundary and its production to the southern boundary of Section 14, Block IX aforesaid; thence easterly along that boundary to the western boundary of Section 47, Block IX aforesaid; thence southerly along that boundary and the western boundaries of Sections 56 and 57, Block IX aforesaid and Section 16, Block VIII, Clarendon Survey District and the production of that last-mentioned boundary to the western boundary of Section 15, Block VIII aforesaid; thence southerly along that boundary and its production to the western boundary of Section 28, Block VIII aforesaid; thence southerly along that boundary and the western boundary of section 29, Block VIII aforesaid to the north-eastern side of the Clarendon-Circle Hill Road; thence generally south-easterly along the north-eastern side of that road to the Clarendon-Berwick Road; thence north-easterly along the north-western side of that road to the south-western boundary of Block X, Waiholā Survey District; thence south-easterly along that south-western boundary to the shore of Lake Waiholā; thence generally north-easterly along the south-eastern shore of that lake to the north-western boundary of Block XXI, Waiholā Survey District; thence generally north-easterly along that north-western boundary to the south-western boundary of Maungatua Survey District; thence generally south-easterly along that south-western boundary to the point of commencement.

At the Government House at Wellington this 31st day of August 1960

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Rabbits Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Hakataramea Valley Rabbit District Order 1960.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The boundaries of the Hakataramea Valley Rabbit District, which was constituted by Order in Council on the 1st day of June 1949,* are hereby altered and redefined and, as from the commencement of this order, the boundaries of the said district shall be those specified in the Schedule hereto.

SCHEDULE

BOUNDARIES OF THE HAKATARAMEA VALLEY RABBIT DISTRICT

ALL that area in the Mackenzie and Waimate Counties, Canterbury Land District, containing 128,276 acres, more or less, commencing at the confluence of the Hakataramea and Waitaki Rivers and proceeding north-westerly along the middle of the Waitaki River to a point in line with the south-eastern boundary of Rural Section 12270; thence north-easterly generally to and along the south-eastern and north-eastern boundaries of Rural Section 12270, the north-eastern and north-western boundaries of Rural Section 11442, the north-eastern boundaries of Rural Sections 29561, 35961, and 35960, the eastern boundaries of Lots 6 and 1, D.P. 2739 (sheet 1), and the south-eastern boundary of Lot 2, D.P. 2739 (sheet 2), to the easternmost corner of Registered Lease No. 10115; thence north-westerly along the north-eastern boundary of the said lease No. 10115 to the north-western boundary of Lot 2, D.P. 2739 (sheet 2), on the summit of the Kirkliston Range, west of Trig. AA, Block I, Hakataramea Survey District; thence north-easterly generally along the north-western boundary of Lots 2 and 3, D.P. 2739 (sheets 2 and 3), to and along the south-eastern and eastern boundaries of Run 70A to the southern boundary of Run 252; thence easterly and north-easterly generally along the southern and south-eastern boundaries of Run 252 to and along the road passing through Rural Section 30128 to and along the north-eastern boundary of Rural Section 30128 and its production to the middle of Dalgety Stream; thence easterly generally along the middle of that stream to the middle of the Hakataramea River; thence northerly generally along the middle of that river, to and along the western boundaries of Sections 2 and 1, Block VIII, and Section 1, Block IV, Mackenzie Survey District, to the
