Boundaries of Borough of Port Chalmers, County of Waikouaiti, and North-east Valley Riding of County of Waikouaiti Defined

Station; thence north-westerly along a right line to Silver Peak Trig. Station; thence north-westerly along a right line to seasternmost corner of Block IX, Silver-peak Survey District and along the north-eastern boundary of that Block VI, to the southern boundary of that Block IX, and the production of the western boundary of that Block IX, and the production of the western boundary of that Block IX, to the right bank of the Three O'Clock Stream; thence generally south-westerly along that bank of that stream to the southernmost corner of Section 5. Block VIII, Silverpeak Survey District; thence generally northerly along the western boundaries of Section 5 aforesaid, Runs 1718, 1716, and 171c to a point due east of Trig.
