

SCHEDULE

LINES for the supply of electrical energy by the system of supply hereinbefore described, commencing from the Horowhenua Electric Power Board's lines at a pole situated on the southern boundary of Section 4c 1, and proceeding in a north-easterly direction to a transformer situated in Section 4c 1 aforesaid, and thence:

- (1) In a north-easterly direction to a pole, and thence;
 - (a) In a north-westerly direction to a cowshed situated in Section 4c 1 aforesaid.
 - (b) In an easterly direction to a house situated in Section 4b 2.
- (2) In a south-westerly direction generally to a cowshed and a house situated in Section 4b 2 aforesaid.

All being situated in Block III, Mount Robinson Survey District, in the County of Manawatu; the said lines being more particularly shown by means of broken red and green lines on the plan marked N.Z.E.D. 556 deposited in the office of the New Zealand Electricity Department at Wellington.
