

a right line across the said road to and along the generally eastern and northern boundaries of the said Section 12A, the eastern boundary of Section 4A of the said Block II, and easterly along the southern side of Waimatenui Road to a point due south of the south-eastern corner of Section 1, Block II aforesaid; thence along a right line across the said road to the said south-eastern corner and along a right line between that corner and the southern corner of Section 6, Block XV, Punakitere Survey District, to its intersection with the middle of the Mangakahia River, crossing a public road; thence easterly generally down the middle of the said river to a point in line with the eastern boundary of Section 6 aforesaid, and along a right line across a public road to and along that eastern boundary to the southern side of another public road, and along another right line across that road to and along the eastern and generally northern boundary of Section 3, Block XV aforesaid, and the production of that boundary to the middle of the stream forming the north-eastern boundary of the said Section 3, and down the middle of the said stream, to and down the middle of the aforesaid Mangakahia River to a point in line with the north-eastern boundary of Aukumeroa 2 Block; thence easterly generally along a right line to and along that north-eastern boundary, and along a right line, being that boundary produced, to the middle of the aforesaid Mangakahia River; thence down the middle of the said river, to and up the middle of the Awarua River to a point in line with the southern boundary of the northern part of Nukutawhiti Block; thence along a right line to and along the southern and north-eastern boundaries of the said northern part of Nukutawhiti Block, to and down the middle of the Kaikou River, to a point in line with the western boundary of Kaikou D 3 Block; thence along a right line crossing a public road to and along the said western boundary, along the western and south-western boundaries of the Kaikou A 3E Block, and along a right line, being the last-mentioned boundary produced, to the middle of the Rotohanganui Stream; thence down the middle of the said stream to a point in line with the south-eastern boundary of Kaikou A 3A Block, and along a right line across a public road, to and along the said south-eastern boundary, along a right line across a public road and the said Kaikou River, to and along the south-eastern boundaries of Kaikou A No. 2 and 1 Blocks, along the south-western, south-eastern, and north-eastern boundaries of Maromaku Block, along the southern boundaries of Lots 63 and 64, D.P. 9582, to and along the south-western and eastern boundaries of Section 4, Block XII, Motatau Survey District, along the southern boundary of Section 18, Block IX, Hukerenui Survey District, and along a right line, being the last-mentioned boundary produced, across Marlow Road to its eastern side; thence northerly generally along that eastern side to and along the southern boundary of Section 22, to and southerly along the western boundary of Section 29, along the southern boundaries of Sections 29 and 30, and the south-eastern, eastern, and north-eastern boundaries of Section 31, all the aforesaid sections being of the said Block IX, to and along the eastern side of a public road which forms the eastern boundary of Section 28, to and along the southern side of Paiaka Road to a point due south of the westernmost corner of Section 52, Block X, Hukerenui Survey District; thence along a right line across Paiaka Road, to and along the southern side of that road and Wallace Road to a point in line with the eastern boundary of Section 35, Block IX, aforesaid, and along a right line to and along that eastern boundary, to and along the southern and eastern boundaries of Section 15, Block X, aforesaid, along the eastern boundaries of Sections 14, 13, 12, part 11, 3, 2, and 21, all of the said Block X, crossing an intervening public road, to and along the southern boundaries of Sections 55 and 64, along a right line across a public road to and along the southern boundaries of Sections 72, 31, 3, and 4, and the western, southern, and eastern boundaries of Section 8, all the aforesaid sections being of Block VI, Hukerenui Survey District, and along a right line, being the last-mentioned boundary produced, to the northern side of the Awanui-Bluff State Highway No. 1; thence south-easterly along the northern side of that highway, to and along the eastern side of Tapuhi Road, crossing the railway at Hukerenui Railway Station, to the middle of Waipukakahau Stream; thence down the middle of that stream, to and up the middle of the Waiotu River to a point in line with the eastern side of the aforesaid Tapuhi Road; thence northerly along a right line to and along the eastern side of that road, to and along the southern and eastern boundaries of Lot 3, D.P. 43284, along the eastern boundaries of Sections 46, part 43, 61, and 41, all of the said Block VI, to and along the southern and eastern boundaries of Section 2, Block VII, Hukerenui Survey District, along the eastern side of a public road forming the generally eastern boundaries of Sections 9 and 10, Block III, Hukerenui Survey District, to a point in line with the easternmost boundary of Section 10, Block III aforesaid; thence along a right line across the said road to and along the eastern boundaries of Sections 10 and 24 of the said Block III, and along the southern side of a public road forming the northern boundary of Section 22, Block III aforesaid, to a point in line with the southern boundary of part Puhipuhi 3 Block (provisional State forest, *Gazette*, 1921, page 1636); thence along a right line to and easterly and then northerly generally along the southern, eastern, and northern boundaries of that block, along the generally eastern boundary of Taumatahinau Block, to and along the south-eastern boundary of Waikare 14B 2 Block, to and along the eastern and north-eastern boundaries of Waikare 17 Block (State forest, *Gazette*, 1948, page 233), the north-eastern boundaries of Waikare 16A and

16B Blocks, and the eastern boundaries of Waikare 7A, part 7B, the end of a public road, another part of 7B, part 4 and 4A Blocks to the north-eastern corner of the last-mentioned block; thence due north to and along the south-western and western boundaries of Section 8, Block VII, Russell Survey District, and the western and north-western boundaries of part Tutaematai B 2 No. 4 Block, to and along the south-western boundaries of Whangaroa-Ngaiotonga 4A 7B, 4A 3, and 4A 2 Blocks, the south-western and south-eastern boundaries of Whangaroa-Ngaiotonga 4A 1 Block, and the south-eastern boundaries of Whangaroa-Ngaiotonga 4A 2 aforesaid, 4A 3 aforesaid, 4A 4, 4A 7A, and 4A 6 Blocks to the point of commencement, together with all the islands known as the Hen and Chickens Islands (Taranga and Maro Tiri), the Poor Knights, and all other islands adjacent to the coastline of the county, and excluding therefrom the Borough of Whangarei as hereinbefore described, and the Town District of Hikurangi, as described in *Gazette*, 1908, page 1170, and the Town District of Kamo, as described in *Gazette*, 1929, page 385.

#### BOUNDARIES OF MANAIA RIDING

All that area in the County of Whangarei commencing at the southernmost corner of Lot 22, D.P. 4396, in Block V, Whangarei Survey District, and proceeding north-easterly along the north-western boundaries of Allotments 42, 43, and 44, Whangarei Parish, and shown on D.P. 4396, to and along the northern boundary of the said Allotment 44 and along a right line, being that boundary produced, to the middle of the Hatea River; thence up the middle of that river to a point in line with the northern boundary of Allotment 19, Parahaki Parish; thence north-easterly generally along a right line to and along the northern and eastern boundaries of the said Allotment 19 to a point in line with the southern boundary of Allotment 20; thence along a right line across a public road to and along the southern and eastern boundaries of the said Allotment 20, along the southern boundary of part Allotment 31, shown on D.P. 21406, and along a right line, being the last-mentioned boundary produced, across a public road, to and southerly along the western and southern boundaries of Allotment S. 30, and along a right line, being the last-mentioned boundary produced, across Allotment 107 to its eastern boundary; thence northerly along that eastern boundary, to and easterly along the southern boundaries of Allotments 38 and 39, all the aforesaid allotments being of Parahaki Parish, and the last-mentioned boundary produced to the middle of a road forming the eastern boundary of the said Allotment 39; thence north-easterly generally along the middle of that road and the middle of the road forming the eastern boundaries of Allotments 52, 53, 54, and 47, Parahaki Parish, and that middle line produced to the south-eastern boundary of Section 4, Block VI, Whangarei Survey District; thence along that south-eastern boundary and that boundary produced across the intervening public road to the westernmost corner of Section 5, Block VI aforesaid; thence south-easterly along the south-western boundary of the said Section 5 and Section 1 and the last-mentioned boundary produced, to and down the middle of the Taheke River to a point in line with the south-eastern boundary of Section 1, Block VI aforesaid; thence north-easterly along a right line to and along that south-eastern boundary and along the southern side of a public road forming the northern boundary of the said Section 1, and that roadside produced to the middle of the Waitangi River; thence easterly generally down the middle of that river and the middle of the Horahora River, to and southerly generally along the sea coast to the entrance of the Whangarei Harbour; thence westerly and northerly generally along the shore of the said harbour, to and along the generally eastern boundaries of the Whangarei Borough as hereinbefore described to the point of commencement, and including therein the islands in Parua Bay and Patuaa, Motukaroro, and other adjacent islands.

#### BOUNDARIES OF KIRIPAKA RIDING

All that area in the County of Whangarei bounded by a line commencing at the southernmost corner of Section 10, Block XVI, Hukerenui Survey District, and proceeding north-easterly generally along the south-eastern boundary of that section and that boundary produced to the eastern side of a public road forming the generally eastern boundary of the aforesaid Section 10; thence along the eastern side of the said road to and along the northern boundary of Section 3, Block XVI aforesaid, crossing the intervening Otonga-Marua road and that boundary produced to and up the middle of the Te Waiongatahuna Stream to a point in line with the southern boundary of Section 13, Block VII, Opuawhanga Survey District; thence along a right line to and along that southern boundary and the southern boundaries of Sections 35 and 46, Block VII aforesaid, to and along the southern and eastern boundaries of Section 47, and along a right line crossing Section 42 to the south-western corner of Section 44, thence still north-easterly generally along the general southern boundary of Section 44, all the aforesaid sections being of the said Block VII, and the last-mentioned boundary produced to and along the middle of Jubilee Road and along the middle of a public road forming the southern boundaries of Section 12, Block VII, Sections 37, 35, 28, and 26, Block VIII, and parts Sections 8 and 7, Block V, all the aforesaid sections being of Opuawhanga Survey District, to and down the middle of a stream which crosses the aforesaid road, to and down the middle of the Whananaki Inlet, to and southerly generally along the sea coast to the middle of the mouth of the Horahora River in Block VIII, Whangarei
