nereby orders the members of the said Federation and the members of its constituent Associations to terminate the said agreement or arrangement And further orders the members of the said Federation and of its constituent Associations not to revive the said agreement or arrangement or to enter into any agreement or arrangement of substantially the same nature or to repeat in any form the said trade practice And further orders the said Federation to rescind not later than the 31st day of May 1961 its resolution passed on the 19th day of February 1958 embodying a minimum charge for an adult funeral of £39 plus the usual disbursements And further orders the said Federation not to adopt any resolution of substantially the same nature embodying a mini-mum charge for performing funeral burial or allied services in connection with non-contract funerals And further orders the said Federation and the said con-stituent Associations to advise their respective members in writing on or before the 30th day of April 1961 that they are not bound to adopt a minimum charge for an adult funeral of £39 plus the usual disbursements. And further orders the said Associations to discontinue the said practice of entering into contracts for funeral burial and allied services with the New Zealand Government Stores Board on behalf of the members of the said Associations and to terminate any such existing contracts on the 30th day of Amil 1061 April 1961

And further orders the said Associations not to revive the said practice of entering into contracts on behalf of the mem-bers of the said Associations or to observe any other practice of substantially the same nature or to repeat in any form the said practice

And further orders the said Associations to advise each of their members in writing on or before the 30th day of April 1961 that no further such contracts will be made on their behalf and that each Association member will as from the date of publication of this order be free to tender individually for such contracts at such price or prices and on such terms and conditions as such member may determine.
