ALL that area in the Southland Land District containing by estimation 451,500 acres, more or less, inclusive of roads, railways, and streams and bounded as follows: Commencing at the junction of the sea coast and the left bank of Big River being a point on the boundary of the Fiordland National Park as described in the Fifth Schedule to the National Parks Act 1952 and amended by Gazette, 1956, p. 1607; thence proceeding north-easterly generally along the Fiordland National Park boundary to the northern boundary of Block VIII, Monowai Survey District; thence westerly generally along the northern boundary of the said Block VIII to the eastern shore of Lake Monowai; thence north-westerly generally along the said eastern shore, across the mouth of the Monowai River and along the northern shore of Lake Monowai to a point in line with the north-western side of Lake Road; thence north-easterly to and along the said north-western side and along the western boundary of Run 463 to Trig.
