PURSUANT to section 6 (2) of the Maori Social and Economic Advancement Act 1945, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, do hereby vary a Proclamation published in the *Gazette* on 20 January 1949 at page 48 declaring parts of New Zealand to be a tribal district under the Maori Social and Economic Advancement Act 1945, by substituting for the name Westland Tribal District appearing in the Schedule thereto the name Kotuku Tribal District.
