ORDER IN COUNCIL

At the Government House at Wellington this 23rd day of August 1961

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 128 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby approves of the resolution passed by the Auckland City Council on the 6th day of March 1961, and set out in the First Schedule hereto, in so far as it affects the side and portion of the street described in the Second Schedule hereto, subject to the condition that no building or part of a building shall at any time be erected on the land fronting the portion of street described in the Second Schedule hereto within a distance of 28 ft from the centre line of the said portion of street.

FIRST SCHEDULE

THE Auckland City Council, being the local authority having control of the streets in the City of Auckland, by resolution declares that the provisions of section 128 of the Public Works Act 1928 shall not apply to the northern side of Mount Street fronting a subdivision of part Allotment 27, Section 33, City of Auckland, comprised in certificate of title, Volume 755, folio 190, and more particularly shown coloured red on plan A. 2245/3, subject to the condition that no building or part of a building shall at any time be erected on the said land within a distance of 28 ft from the centre line of the said portion of the said street.

SECOND SCHEDULE

NORTH AUCKLAND LAND DISTRICT

THE northern side of all that portion of Mount Street in the City of Auckland fronting part Allotment 27, Section 33, Town of Auckland; as the same is more particularly delineated on the plan marked M.O.W. 3437 deposited in the office of the Minister of Works at Wellington, and thereon coloured red.
