Tariff Notice—Application for Approval of the Minister of Customs

NOTICE is hereby given that an application has been made for the classification, by approval of the Minister of Customs, of the under-mentioned goods under item 199 (1) (a) of the Customs Tariff of New Zealand:

Nylon tubing not exceeding 10m.m. outside diameter and not exceeding 7m.m. in wall thickness.

The application will not be dealt with until 12 October 1961, and any person wishing to submit any objection thereto should do so in writing to the Comptroller of Customs, Private Bag, Wellington, on or before 12 October 1961.

Any objection should be supported by information as to:

- (a) The range of goods manufactured;
- (b) The proportions of New Zealand and imported materials used in manufacture;
- (c) Present and potential output; and
- (d) Details of factory costs in terms of materials, labour, overhead, etc.

Tariff Notice—Application for Withdrawal of Approval by the Minister of Customs

NOTICE is hereby given that an application has been made for withdrawal of the approval, by the Minister of Customs, of the under-mentioned goods under item 448 (3) of the Customs Tariff of New Zealand:

Plywood when declared by a manufacturer for use by him only in making radio cabinets.

Plywood so declared is, at present, subject to the following rates of duty:

British Preferential Tariff—3 per cent.

General Tariff—25 per cent plus surtax of nine-fortieths of the amount of duty.

The application will not be dealt with until 12 October 1961, and any person wishing to submit any objection thereto should do so in writing to the Comptroller of Customs, Private Bag, Wellington, on or before 12 October 1961.

Any such objection should be supported by:

- (a) Information as to whether suitably equivalent goods are available or can be produced in New Zealand; and
- (b) Details of landed cost and selling price, including c.d.v., and cost into store in terms of f.o.b., insurance, freight, exchange, other landing charges, and duty.
