Defining the Limits of the Gisborne Harbour Pilotage District

COBHAM, Governor-General

PURSUANT to section 211 of the Harbours Act 1950, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, hereby define the limits of the Gisborne Harbour Pilotage District, within which pilots may act for the purposes of the said Act, to be all the tidal waters comprised within Gisborne Harbour and Poverty Bay having as their outward seaward limit the arc of a circle running from the landward boundary of the western foreshore of Tuaheni Point and thence into Poverty Bay and thence to the landward boundary of the north-western foreshore of Poverty Bay, such arc being an arc of a circle of three nautical miles radius having as its centre the West Groyne light structure sited approximately at 38° 40′ 41″ south and 178° 01′ 10″ east.
