"(iv) A rate of 37.2120d. per acre on the total acreage of all property classified as Class D in the Waitaha Settlement Drainage Scheme Special Rating District as defined in the classification list and plan No. 901/9 deposited in the office of the said the Westland Catchment Board at Greymouth.

"(v) A rate of 24.8088d. per acre on the total acreage of all property classified as Class E in the Waitaha Settlement Drainage Scheme Special Rating District as defined in the classification list and Plan No. 901/9 deposited in the office of the said the Westland Catchment Board at Greymouth.

"(vi) A rate of 12.4044d. per acre on the total acreage of all property classified as Class F in the Waitaha Settlement Drainage Scheme Special Rating District as defined in the classification list and Plan No. 901/9 deposited in the office of the said the Westland Catchment Board at Greymouth.
