

part 66B 3D 1, 66B 3B, and west part 66B 3D 1B of the said parish, a right line across Te Uku - Tuakau Road, to and along the northern boundary of that portion of Allotment 66B 3C 3C aforesaid, situated in Block XIV, Whaingaroa Survey District, and the production of that boundary to the middle of the Ohautira River; thence down the middle of that river to its mouth, and along a right line to the northern shore of Raglan Harbour; thence northerly, south-westerly, and again northerly generally along the northern shore of the aforesaid harbour and the sea coast to the point of commencement.

WAIPA

All that area bounded by a line commencing at a point in the middle of the mouth of the Ohautira River, in Raglan Harbour; thence easterly generally along the boundaries of the Electoral Districts of Raglan and Hamilton, hereinbefore described, to the middle of the Mangaonua Stream at its confluence with the Mangaone Stream in Block II, Hamilton Survey District; thence south-easterly generally up the middle of the Mangaone Stream and the Mangaomahu Stream to the middle of Pickerings Road; thence southerly generally along the middle of that road, No. 1 National State Highway, Savills Road, and its production to the middle of the Waikato River; thence up the middle of the aforesaid river to a point in line with the eastern boundary of part Allotment 161, Hautapu Parish; thence northerly along a right line, to and along the last-mentioned eastern boundary, the eastern boundaries of part Allotment 161A, other parts of Allotment 161, a right line across No. 1 National State Highway, to and along the eastern boundaries of part Lot 1, D.P. 19847, Lots 11, 12, 13, and part Lot 1, D.P. 8387, and the eastern boundary of Allotment 18, all the aforesaid being of Hautapu Parish, to a point in line with the southern boundary of part Allotment 184 of the aforesaid parish on D.P. 20810; thence easterly along a right line across Vogel Street, to and along the southern boundary aforesaid, along another right line across Victoria Street, the Hamilton-Cambridge Railway, and the Hautapu Stock Road, to and along the southern boundaries of Lot 3, D.P. 26594, and parts Lot 1, D.P. 31753 (secondary school site), along a right line across Bowen Street, to and along the southern boundaries of part Lot 1, D.P. 172, Lots 1 and 2, D.P. 16740, a right line across a public road, to and along the southern boundaries of Lot 20, D.P. 252, and Lot 1, D.P. 17516, to the western boundary of Allotment 215, Hautapu Parish, on D.P. 2181; thence southerly generally along the aforesaid western boundary, the western boundary of Allotment 216 of the said parish, a right line across Thornton Road, to and along the western boundaries of Lots 1 and 2, D.P. 14436, a right line across No. 1 National State Highway, to and along the western boundary of Section 21, Block IX, Cambridge Survey District, and the western boundary of an area reserved under Section 58 of the Land Act 1948 and that boundary produced to the middle of the Waikato River; thence easterly up the middle of the aforesaid river to a point in line with the western boundary of part Pukekura 1 shown on D.P. 27186; thence southerly generally along the said western boundary of Pukekura 1, along a right line crossing a public road, to and along the generally western boundary of part Pukekura 1, part Section 1, Block XIV, Cambridge Survey District, parts Pukekura 1, 2, and 3, part Pukekura 4, shown on D.P. 9392, Pukekura 5, Section 1, and part 6; thence along the southern and western boundaries of part Pukekura 7, the western boundaries of Pukekura 8A, parts 9, 10, 11, 12, 13, and 14, to the southernmost corner of the said part 14; thence along a right line in the direction of Trig. Station 1427 (Maungatautari), in Block VII, Maungatautari Survey District, to its intersection with the eastern boundary of Maungatautari 3A 5A 8; thence southerly generally along the aforesaid eastern boundary, to and along the eastern and southern boundaries of Maungatautari 3A 5A 1, a right line across Maru Road, to and along the eastern and southern boundaries of part Lot 4, D.P. 12622, the eastern boundaries of Sections 3, 5, and 11, Block V, Maungatautari Survey District, a right line across Te Reti Road, to and along the eastern boundaries of Sections 5 and 6, Block IX, Maungatautari Survey District, aforesaid, and a right line to the middle of the Mangaohoi Stream; thence westerly generally down the middle of the said stream, along a right line, to and along the left bank of the Mangapiko Stream to the easternmost corner of that part of Allotment 317, Mangapiko Parish, shown on S.O. plan 21552, Block II, Puniu Survey District; thence southerly generally along the south-eastern boundary of the aforesaid Allotment 317, and along a right line across Alexander Street, to and along the eastern boundaries of Allotments 242 and 243, to the south-eastern corner of that part of the last-mentioned allotment shown on S.O. plan 39160, all the aforesaid allotments being of Mangapiko Parish; thence easterly generally along a right line across Rewi Street and part Allotment 228, to and along a right line on a bearing of $264^{\circ} 30'$ for a distance of 3700 links from Peg VIII on the North Island Main Trunk Railway shown on S.O. plan 3908, Sheet 1, crossing parts Allotments 228, 229, 230, and the said railway; thence along another right line across the aforesaid railway to the north-eastern corner of Allotment 232; thence westerly along the north-western boundary of the aforesaid Allotment 232, to and along the north-eastern and north-western boundaries of Allotment 322, all the aforesaid allotments being of Mangapiko Parish, and along a right line, being the last-mentioned boundary produced to the middle of the Puniu River; thence down the middle of that river and the middle of the Waipa River, to and up the middle of the Mangauika Stream, to and westerly along the northern boundaries of Sections 2 and 11, Block IV, Pirongia Survey District, the northern and western boundaries of Section 9, Block IV, aforesaid, and the western boundary of Section 10 of the said Block IV, to and along the northern and western boundaries of Kaipiha No. 5 Block, and the western boundaries of Kaipiha Nos. 4, 3, 2, and 1c Blocks, to and along the northern boundary of part Section 3, Block VII, Pirongia Survey District, to the eastern boundary of Section 18 of the said Block VII; thence northerly along the eastern boundary of the said Section 18, the south-western and north-western boundaries of Section 6, Block III, Pirongia Survey District, and the northern boundary of Mangauika B No. 2 No. 2 Block, to Trig. Station 1922, Mahaukura; thence westerly generally along the south-western boundary of Allotment 358, Pirongia Parish, the end of a public road, the south-western boundaries of Allotments 352 and 428, Pirongia Parish, aforesaid, and the end of another public road to Trig. Station Tahuauui; thence along the south-eastern, southern, and western boundaries of Part Moerangi No. 4 Block, and along the southern boundary of Section 6, Block I, Pirongia Survey District, to its south-western corner, being an angle in the Otungaoko Road; thence along a right line across the said road to the opposite angle, and along the western side of the said road, to and along the southern and western boundaries of Section 7, Block I, of the said survey district, along the southern boundary of Section 4, Block IV, Kawhia North Survey District, and a right line from its south-western corner across Koponui Road to the nearest
