

on the shore of Port Nicholson in line with the north-eastern boundary of Lot 23, D.P. 2205, being part Section 13, Harbour District; thence south-westerly along the shore of Port Nicholson to a point in line with the middle of Westminster Street; thence westerly generally along a right line, to and along the middle of that street across Hutt Road, to and along the middle of Fore Street, the south-western part of Winchester Street and its production, to and along the middle of Ngaio Gorge Road East to a point in line with the north-western boundary of Lot 224, D.P. 2644; thence along the production of that boundary to the middle of the Kaiwharawhara Stream; thence up the middle of that stream to a point in line with the north-western boundary of Lot 3, D.P. 3932; thence to and along the north-western boundaries of Lots 3 and 2, D.P. 3932, and the production of the last-mentioned boundary to the middle of Oban Street; thence along the middle of Oban Street and Buchanan Street to a point in line with the middle of Moorhouse Street; thence to and along the middle of that street, Lennel Road, Sefton Street, and Wadestown Road to the northern boundary of the Town Belt Reserve; thence south-westerly along a right line to Upper Witako Trig. Station on Tinakori Hill; thence westerly generally along a right line to the middle of the eastern end of Huntingdon Street; thence along the middle of Huntingdon Street, Pembroke Road, Cheshire Street, and Worcester Street to its junction with Wilton Road; thence due west to the middle of the Kaiwharawhara Stream; thence southerly generally along the middle of that stream, to and along the southern boundary of part Section 31, Karori District, on Plan A 2267, to and along the middle of Curtis Street, Old Karori Road, Chaytor Street, and Waiapu Road, to and along the eastern boundary of the Wellington Water Supply Area, to and along the western side of Highbury Road, to and again along the eastern boundary of the said Wellington Water Supply Area and the southern boundary of George Denton Park to the western boundary of Section 30, Owhiro District; thence southerly along the western boundaries of Sections 30, 13, 14, 16, 17, 19, 21, 22, 24, 25, and 27, Owhiro District, and the production of the last-mentioned boundary to the sea coast; thence westerly and northerly generally along the sea coast to the point of commencement.

WELLINGTON CENTRAL

All that area bounded by a line commencing at a point on the shore of Port Nicholson in line with the middle of Westminster Street; thence southerly, easterly, and again southerly generally along the shores of Port Nicholson and Evans Bay to a point in line with the southern boundaries of Lots 3 and 2, D.P. 4203; thence south-easterly generally along a right line across Evans Bay Parade, to and along the aforesaid southern boundaries, to and along the middle of Maida Vale Road, Grafton Road, Palliser Road, Roseneath Terrace, Thane Road, and Alexandra Road to the middle of the Mount Victoria Tunnel; thence north-westerly generally along the middle of that tunnel, to and along the middle of Paterson Street to a point on the south-eastern boundary of Section 669, Town of Wellington; thence south-westerly and north-westerly along the south-eastern boundaries of the said Section 669 and Sections 670 and 671, Town of Wellington, the south-western and north-western boundaries of the said Section 671 to a point in line with the middle of Rugby Street; thence to and along the middle of that street, Tasman Street, and Tainui Terrace, to and along the southern boundary of Section 716, Town of Wellington, to the eastern boundary of the Technical College Reserve; thence southerly, westerly, and northerly along the boundaries of that reserve to the middle of Hankey Street; thence north-westerly generally along the middle of Hankey Street, Taranaki Street, Arthur Street, Cuba Street, Abel Smith Street, Willis Street, Aro Street, and Epuni Street to a point in line with the northern boundary of Lot 1, D.P. 9754; thence to and along that northern boundary and its production to the middle of Durham Crescent; thence along the middle of Durham Crescent and Durham Street, to and along the western boundary of Section 1153, Town of Wellington, to the northern boundary of Section 30, Owhiro District; thence westerly and southerly along the northern and western boundaries of Section 30 aforesaid, to the southern boundary of George Denton Park; thence north-easterly generally along the boundary of the Electoral District of Karori, hereinbefore described, to the point of commencement; and including Somes Island and all wharves and other extensions seaward.

ISLAND BAY

All that area bounded by a line commencing at a point on the sea coast in line with the western boundary of Section 27, Owhiro District, in Block XIII, Port Nicholson Survey District; thence northerly and easterly generally along the boundaries of the Electoral Districts of Karori and Wellington Central, hereinbefore described, to the intersection of the middle lines of the Mount Victoria Tunnel and Alexandra Road; thence southerly generally along the middle of Alexandra Road and Crawford Road to a point in line with the south-eastern boundary of the Town Belt Reserve; thence to and along that boundary to its intersection with the middle of Hornsey Road; thence along the middle of Hornsey Road, Houghton Bay Road, Buckley Road, Melrose Road, and Highgate Road to a point on the right line from the intersection of the southern boundary of the Town Belt Reserve aforesaid with the middle line of Houghton Bay Road to Trig. Station Island Bay No. 2; thence southerly along that right line to the said trig. station and along another right line to Eldson Point on the sea coast; thence westerly generally along the sea coast to the point of commencement; and including all adjacent islands.

MIRAMAR

All that area bounded by a line commencing at a point on the shore of Evans Bay in line with the southern boundaries of Lots 3 and 2, D.P. 4203; thence southerly, easterly, and northerly along the shore of Evans Bay to Point Halswell; thence southerly and westerly generally along the shore of Port Nicholson and the sea coast to Eldon Point; thence north-easterly generally along the boundaries of the Electoral Districts of Island Bay and Wellington Central, hereinbefore described, to the point of commencement; and including all wharves and other extensions seaward.

WESTLAND

All that area bounded by a line commencing at a point on the sea coast in the middle of the mouth of the Punakaiki River, and proceeding up the middle of that river to its source; thence south-easterly along a right line to Mount Anderson on the summit of the Paparoa Range; thence north-easterly
