north-westerly along the middle of Ferry Road to the middle of Tilford Street; thence northerly generally along the boundary of the Electoral District of Christchurch Central, hereinbefore described, to the middle of the Avon River in line with the middle of Banks Avenue; thence northerly generally along the boundary of the Electoral District of St. Albans, hereinbefore described, to the intersection of the middle of Marshland Road and the middle of Lake Terrace Road; thence easterly generally along the boundary of the Electoral District of Rangiora, hereinbefore described, to the sea coast; thence south-easterly along the sea coast to the north head of the estuary of the Avon and Heathcote Rivers; thence along a right line to the point of commencement.

intersection of the middle of Moorhouse Avenue and the middle of Lincoln intersection of the middle of Moorhouse Avenue and the middle of Lincoln

All that area bounded by a line commencing at Point Golland at the south head of the Estuary of the Avon and Heathcote Rivers, and proceeding southeasterly, southerly, and westerly generally along the sea coast, crossing the mouths of all harbours and inlets, to the former outlet of Lake Ellesmere east of Maori Reserve 878; thence north-easterly along a right line to the middle of the mouth of the Halswell River on the northern shore of Lake Ellesmere and the production of that right line to the left bank of that river; thence northerly generally along the left bank of the Halswell River to the southernmost corner of Rural Section 1069, Block X, Halswell Survey District; thence along the production of the south-eastern boundary of the said section to the middle of the Halswell River; thence north-westerly generally up the middle of the Halswell River to a point in Block II, Halswell Survey District, in line with that north-eastern boundary of Rural Section 1329/1330 measuring 91 links; thence north-westerly to and along that boundary to Old Taitapu Road thence along a right line to the south-western corner of Lot 4, D.P. 5068; thence along the south-western and north-western boundaries of the said Lot 4, the north-western boundaries of part Lot 5, D.P. 5068, Lot 4, D.P. 14253, and Lot 2, D.P. 14689, and the north-western and north-eastern boundaries of Lot 1 D.P. 14689, to Kennedys Bush Road; thence south-easterly along the southwestern side of that road to a point in line with the middle of Paterson Avenue thence northerly to and along the middle of Paterson Avenue, north-easterly generally along the middle of Cashmere Road, and north-westerly along the
