## SELWYN

All that area bounded by a line commencing at a point on the sea coast in the middle of the mouth of the Ashburton River and proceeding up the middle of the said river to a point in line with the south-eastern side of Trevors Road, in Block XIII, Ashburton Survey District; thence to and along the south-eastern side of Trevors Road and its production to the north-eastern side of Albert Street; thence north-westerly along the north-eastern side of Albert Street to the southernmost corner of Lot 6, D.P. 15602; thence along the south-eastern boundaries of Lot 6, D.P. 15602, and part Lot 7, D.P. 988, to a point in line with the north-eastern boundary of Lot 5, D.P. 11462; thence to and along the north-eastern boundaries of Lots 5 and 4, D.P. 11462, to the northernmost corner of the last-mentioned lot; thence along a right line to the easternmost corner of Lot 3, D.P. 11462; thence along the north-eastern boundaries of Lots 3 and 2, and the north-eastern and north-western boundaries of Lot 1, D.P. 11462, to a point in line with the north-eastern boundary of Lot 2, D.P. 10505; thence to and along the north-eastern boundary of Lot 2, D.P. 10505, and north-easterly along the north-western boundary of Lot 1, D.P. 10505, to the southernmost corner of Lot 6, D.P. 13311; thence along the south-western boundary of the said Lot 6 to a right line parallel to and 250 links south-easterly from the south-eastern side of Bridge Street; thence north-easterly along the said right line to Taurangi Road; thence north-westerly along the south-western side of Taurangi Road to Bridge Street; thence along a right line to the southernmost corner of Reserve 2644; thence along the south-western boundaries of Reserves 2644 and 4878 and the production of the last-mentioned boundary to the north-western side of East Street; thence north-easterly along the north-western side of East Street and the eastern boundary of Reserve 2909 (South Island Main Trunk Railway) to the northernmost corner of the said Reserve; thence along a right line to the intersection of the north-western side of West Street and the south-western side of Racecourse Road; thence north-westerly along the south-western side of Racecourse Road to the easternmost corner of Lot 155, D.P. 236; thence along the south-eastern boundary of the said Lot 155 and its production to the middle of the Wakanui Stream; thence north-westerly up the middle of the said stream to Allens Road; thence south-westerly along the south-eastern side of Allens Road, north-westerly along the middle of Middle Road, and south-westerly along the middle of Farm Road to the middle of Harrison Street; thence along a right line to the intersection of the south-eastern side of Farm Road and the south-western side of Harrison Street; thence along the south-eastern side of Farm Road and its production to the western side of Alford Forest Road; thence southerly along the western side of Alford Forest Road to the northernmost corner of Lot 3, D.P. 864; thence along the north-western boundaries of Lots 3, 19, 20, and 21, D.P. 864, the north-eastern boundary of Rural Section 20864, the south-eastern boundaries of Lots 41 and 42, D.P. 888, and the production of the last-mentioned boundary to the middle of the Ashburton River; thence northerly generally up the middle of the Ashburton River and the middle of the north branch of the Ashburton River to the southern boundary of Run 119 in Block XI, Mount Somers Survey District; thence along the southern and western boundaries of Run 119, the south-eastern and south-western boundaries of Run 118A, and the south-western boundary of Run 118 to the middle of Lake Stream; thence northerly down the middle of that stream to the middle of the Rakaia River; thence westerly up the middle of that river to the middle of the Louper Stream; thence northerly up the middle of that stream to the summit of the Southern Alps; thence north-easterly generally along the summit of the Southern Alps to the summit of the Snowy Range; thence south-easterly generally along the boundary of the Electoral District of Rangiora, hereinbefore described, to the intersection of the middle of Russley Road and the middle of Johns Road; thence south-westerly along the boundary of the Electoral District of Fendalton, hereinbefore described, to the intersection of the middle of Russley Road and the middle of Memorial Avenue; thence south-westerly and south-easterly generally along the boundary of the Electoral District of Riccarton, hereinbefore described, to the intersection of the middle of Halswell Road and the middle of Hendersons Road; thence south-westerly generally along the boundary of the Electoral District of Lyttelton, hereinbefore described, to the sea coast; thence south-westerly along the sea coast, crossing the mouths of all harbours and inlets, to the point of commencement.

## ASHBURTON

All that area bounded by a line commencing at a point on the sea coast in the middle of the mouth of the Ashburton River, and proceeding south-westerly along the sea coast, crossing the mouths of all harbours and inlets, to the middle of the Opihi River; thence up the middle of that river to a point in line with the north-western boundary of Rural Section 10453, in Block IV, Pareora Survey District; thence along a right line to the northernmost corner of the said section; thence along the north-eastern boundary of Rural Section 10453 to Butlers Road; thence south-westerly along the north-western side of that road and its production to the Fairlie Branch Railway; thence south-easterly along the north-eastern side of the said railway to a point in line with the north-western boundary of Rural Section 14284; thence south-westerly to and along the south-eastern side of Keanes Road, to and south-westerly along the south-eastern side of Olivers Road, to and southerly along the eastern side of Downs Road, to and south-westerly along the south-eastern side of Rolling Ridges Road, to the westernmost corner of Section 116, Rosewill Settlement; thence southerly generally along the generally western boundaries of Sections 116 and 117, Rosewill Settlement, and the production of the last-mentioned boundary to the middle of Frasers Road; thence westerly generally along the middle of Frasers Road, Cliffs Road, Rural Section 37764 (closed road), Taipo School Zig Zag Road, Taipo Flat Road, and Limestone Valley Road, to a
