

Green Island West Survey District; thence to and along that boundary, along the eastern, northern, and western boundaries of Section 14, the northern boundaries of Sections 19, 20, and 21, the western boundary of Section 21, the northern boundaries of Sections 22, 23, 24, and 25, the western boundary of Section 25, Green Island West Survey District, and the production of the last-mentioned boundary to the middle of No. 1 National State Highway; thence westerly generally along the middle of the said highway to a point in line with the north-eastern boundary of the Town of Allanton; thence north-westerly to and along that boundary, and south-westerly along the north-western boundary of the Town of Allanton and its production to the middle of the Taieri River; thence south-westerly generally down the middle of that river to the Waipori River; thence north-westerly generally along the southern and south-western boundaries of Block VI, Maungatua Survey District, to Waipori Lake; thence north-easterly generally along the eastern shore of Waipori Lake to the Waipori River; thence westerly generally up the middle of that river to the western boundary of Block XV, Maungatua Survey District; thence northerly along the western boundaries of Blocks XV, XIII, and XII, easterly along the northern boundary of Block XII, Maungatua Survey District, and northerly along the western boundaries of Blocks XII and XI, Waipori Survey District, and the production of the last-mentioned boundary to the middle of Lee Stream; thence north-westerly generally up the middle of that stream to Section 24, Block III, Lee Stream Survey District; thence north-westerly along the south-western boundary of the said Section 24 and the southern boundary of Run 260B to the Pole Track; thence south-westerly, westerly, and north-westerly generally along the Pole Track along the watershed between Deep Stream and the Waipori River to a road intersection south of Trig. Station H, Hedgehope Survey District; thence south-westerly along the northern side of a road to a road corner near Trig. Station F, Hedgehope Survey District; thence along a right line to that trig. station; thence north-westerly generally along the summit of the Lammerlaw Range to Trig. Station H, Lammerlaw Top; thence northerly and south-westerly generally along the eastern and north-western boundaries of original Run 170 to the easternmost corner of Section 13, Block XIII, Benger Survey District; thence along the south-eastern boundaries of Sections 13, 11, and 10, Block XIII, aforesaid, to and along the south-eastern boundaries of Sections 3, 4, and 14, Block XII, Benger Survey District, and the production of the last-mentioned boundary to the middle of the Clutha River; thence north-westerly up the middle of that river to a point in line with the northern boundary of Section 59, Block VI, Benger Survey District; thence westerly to and along the northern boundary of the said Section 59 and its production across an easement to and along the northern boundaries of Section 57, Block VI, aforesaid, and Lots 14, 15, and 50, D.P. 1809, and the production of the last-mentioned boundary to the middle of the Heriot-Roxburgh via Moa Flat Road; thence southerly along the middle of that road to a point in line with the southern boundary of Run 698; thence westerly to and along the southern boundaries of Runs 698 and 696 and the production of the last-mentioned boundary to the middle of the Pomahaka River; thence south-westerly generally down the middle of that river to a point in line with the south-western boundary of Run 609; thence north-westerly generally to and along the south-western boundary of Run 609 to the Umbrella Mountains; thence north-easterly generally along the summit of the Umbrella Mountains to a point due east of Rocky Mountain; thence due west to Rocky Mountain; thence north-westerly along a right line to Lorn Peak; thence northerly generally along the summit of the Hector Mountains and the Remarkables to Double Cone; thence easterly generally along a leading ridge through Trig. Stations N, L, Mount Edward, H, Mount Rosa, O, and I, Kawarau Survey District, and its production to the middle of the Kawarau River near its confluence with the Nevis River; thence northerly generally down the middle of the Kawarau River and up the middle of the Kirtleburn to Run 629, in Block X, Cromwell Survey District; thence westerly generally along the southern boundaries of Run 629, and Sections 54 and 53, Block I, Cardrona Survey District, the south-western boundaries of Sections 53 and 52, Block I, aforesaid, the south-eastern boundary of Section 1, Block III, Crown Survey District, the south-eastern and southern boundaries of Section 2, Block III, aforesaid, and the production of the last-mentioned boundary to the middle of the Cardrona River; thence south-westerly up the middle of that river to a point in line with the south-western boundary of Section 5, Block I, Knuckle Peak Survey District; thence north-westerly to and along that boundary and northerly generally along the western boundaries of Sections 5, 4, and 3, Block I, aforesaid, Section 2, Block II, Knuckle Peak Survey District, and the south-western boundary of Run 340B to Mount Cardrona; thence north-westerly along a right line to Mount Motatapu, in Block X, Motatapu Survey District; thence northerly generally along the western boundaries of Runs 334B, 333A, and 333B, to the Matukituki River; thence westerly along the right bank of that river to Run 468; thence northerly along the eastern boundary of that run and westerly along the southern boundary of Run 97 to the Southern Alps; thence north-easterly generally along the summit of the Southern Alps to Mount Strauchon; thence south-easterly generally along the boundary of the Electoral District of Waitaki, hereinbefore described, to the point of commencement.

#### CLUTHA

All that area bounded by a line commencing at a point on the sea coast in the middle of the mouth of Longbeach Creek, in Block XIII, Tautuku Survey District, and proceeding north-westerly up the middle of that creek to the northern side of No. 92 Provincial State Highway; thence westerly along the northern side of that highway to the eastern boundary of Waikawa Survey District; thence northerly along the eastern boundary and westerly along the northern boundary of Waikawa Survey District to the south-eastern corner of Section 5, Block XIV, Mokoreta Survey District; thence northerly along the eastern boundary of that section and its production to the northern side of a public road; thence north-westerly generally along the northern side of that road to a point due south of Trig. Station EE; thence due north to that trig. station; thence northerly generally along the watershed passing through Table Ridge, Mount Alfred, and Trig. Station G to Trig. Station H, Chimney, in Block III, Mokoreta Survey District; thence north-easterly along a right line to Peg XIII on the south-western boundary of Lot 2, D.P. 3410; thence north-westerly and north-easterly generally along the south-western and north-western boundaries of the said Lot 2 to its northernmost corner; thence north-westerly along the production of the north-eastern boundary of the said Lot 2 to the north-western boundary of Lot 7, D.P. 3410; thence north-easterly generally along the north-western boundary of the said Lot 7 to its northernmost corner;
