

and 23, D.P. 20071, being part of Allotments 159 and 165 of the aforesaid parish, the abutment of Liverpool Street and the south-eastern boundary of Lot 22, D.P. 20071, aforesaid, to the north-eastern corner of the last-mentioned lot; thence along right lines across the North Auckland Railway bearing  $288^{\circ} 01'$  distance 413·46 links, bearing  $18^{\circ} 01'$  distance 72·27 links, bearing  $251^{\circ} 16' 50''$  distance 120·83 links, bearing  $287^{\circ} 57'$  distance 247·16 links, to and along the south-western boundaries of Allotments 162 and 163, Waikomiti Parish, to and along the south-eastern side of the Waikumete West Coast Road to the south-western side of Great North Road; thence along a right line being the production of the north-eastern boundary of Allotment 163 aforesaid, across the Waikumete West Coast Road, to and along the south-western side of Great North Road to a point in line with the middle of Archibald Road; thence to and along the middle of that road to a point in line with the south-western boundary of Allotment 221, Waikomiti Parish; thence to and along the south-western boundaries of Allotments 221 aforesaid, 233, 232, and 230, all of the said parish to the south-eastern side of Sabulite Road; thence southerly along that south-eastern side and its production to the middle of Great North Road; thence north-westerly along the middle of Great North Road to the left bank of Wairau Creek; thence northerly generally along that bank and the left bank of the Whau River, to and along the western shore of Waitemata Harbour to a point in line with the middle of Luckens Road (as formed), being a point on the boundary of the Electoral District of Rodney, hereinbefore described; thence south-westerly generally along that boundary to the point of commencement; and including all wharves and other extensions seaward.

#### NEW LYNN

All that area bounded by a line commencing at a point on the shore of Waitemata Harbour in line with the middle of Saltaire Street; thence easterly along the middle of Saltaire Street, north-easterly along the middle of Great North Road, and southerly generally along the middle of Blockhouse Bay Road, Holbrook Street, Hertford Street, Margate Road, Whitney Street, Donovan Street, and Lewis Street to the shore of Manukau Harbour; thence south-westerly generally along the shore of Manukau Harbour and the left bank of Big Muddy Creek to a point in the middle of the mouth of Nihotupu Stream; thence north-westerly generally along the boundary of the Electoral District of Waitakere hereinbefore described, to a point on the left bank of Wairau Creek in the middle of the Great North Road; thence north-easterly and south-easterly along the middle of that road, to and along the right bank of the Wairau Creek and the left bank of the Whau River to Great North Road at Whau Bridge; thence along the north-western side of that bridge and along the right bank of the Whau River to the northern side of the No. 16 Provincial State Highway; thence easterly generally along the northern side of that highway to and along the generally northern shore of Traherne Island, and again along the northern side of the said highway to the shore of Waitemata Harbour; thence southerly along the shore of Waitemata Harbour to the point of Commencement; and including Pollen Island.

#### GREY LYNN

All that area bounded by a line commencing at the intersection of the northern side of No. 16 Provincial State Highway with the shore of Waitemata Harbour; thence northerly and north-easterly generally along the shore of the said harbour to the western side of Curran Street; thence due east to the middle of Curran Street; thence southerly generally along the middle of Curran Street, Jervois Road, John Street, Lincoln Street, Richmond Road, Brown Street, Fitzroy Street, Richmond Road, Leighton Street, Turakina Street, Great North Road, Brisbane Street, and its production to the south-eastern boundary of Allotment 14, Section 7, Suburbs of Auckland; thence westerly generally along the south-eastern and southern boundaries of Allotments 14, 15, 16, 17, 18, 19, and 20, Section 7, Suburbs of Auckland, to the south-western corner of the last-mentioned allotment; thence south-westerly generally along the eastern boundaries of Allotments 40 and 38 of Section 5, Suburbs of Auckland, and the production of the last-mentioned boundary to and along the middle of Western Springs Road and Asquith Avenue to a point in line with the south-western boundary of Allotment 173 of Section 10, Suburbs of Auckland; thence to and along the south-western boundaries of Allotments 173 and 175 and the south-eastern boundary of Allotment 174, all of Section 10, Suburbs of Auckland, to and along the middle of Meola Stream to a point in line with the eastern boundary of Allotment 29, Titirangi Parish; thence to and along the eastern boundaries of Allotments 29 and 35, the southern boundary of Allotment 35 aforesaid and its production across Carrington Road, to and along the southern boundary of Allotment 32, all of Titirangi Parish, and the production of the last-mentioned boundary to and up the middle of Oakley Creek to a point in line with the northern boundary of Lot 4, D.P. 16351; thence to and along the northern boundaries of Lot 4 aforesaid, and Lot 1, D.P. 16351, the said lots being part Allotment 62, Titirangi Parish, and the production of the last-mentioned boundary to the middle of the Great North Road; thence along the middle of that road to and along the boundary of the Electoral District of New Lynn, hereinbefore described, to the point of commencement; and including all wharves and other extensions seaward.

#### AUCKLAND CENTRAL

All that area bounded by a line commencing at a point on the shore of Hobson Bay in line with the middle of Tohunga Crescent; thence generally south-westerly to and along the middle of Tohunga Crescent, to and along the north-western boundaries of Lot 7, D.P. 9448, and Lot 18, D.P. 2032, to the north-eastern side of Brighton Road; thence along a right line crossing the said road, to and westerly and north-westerly along the southern and south-western boundaries of Lot 1, D.P. 26703 (part of which southern boundary passes along Kenderdine Lane), to and westerly along the southern boundary of Lot 3, D.P. 36074, and its production to and along the middle of Cathedral Place, Parnell Road, and Broadway to a point in line with the middle of Carlton Gore Road; thence along a right line to and along the middle of that road, Grafton Road, Khyber Pass Road, Symonds Street, and Newton Road to a point in line with the south-eastern boundary of Allotment 12 of Section 7, Suburbs of Auckland; thence south-westerly to and along the south-eastern boundaries of Allotments
