

12, 13, and 14 of Section 7, Suburbs of Auckland, to a point in line with the middle of Brisbane Street; thence north-westerly and northerly generally along the boundary of the Electoral District of Grey Lynn, hereinbefore described, to and generally easterly along the southern shore of the Waitemata Harbour, and including all wharves and extensions seaward, to a point on the northern side of Tamaki Drive due north of Point Resolution; thence southerly along a right line, to and along the western shore of Hobson Bay to the point of commencement; and including the islands of Tiritiri, Rangitoto, Motutapu, Rakino, Motuihe, Brown's, Waiheke, Ponui, Pakihi, Rotoroa, Pakatoa, and other adjacent islands, and the Kermadec Islands.

MOUNT ALBERT

All that area bounded by a line commencing at the intersection of the middle lines of the Great North Road and Blockhouse Bay Road; thence southerly along the boundary of the Electoral District of New Lynn, hereinbefore described, to a point in line with the south-western boundary of Lot 9, Deeds Plan 1148, being part Allotment 65, Titirangi Parish; thence easterly and north-easterly to and along the south-western boundaries of Lots 9 and 10, the south-eastern boundaries of Lots 10, 11, and 14, all of Deeds Plan 1148, Lot 2, D.P. 45694, Lots 16, 17, 18, 19, and 20, Deeds Plan 1148, the said lots being part of Allotment 65 aforesaid, and the production of the last-mentioned boundary to the middle of Oakley Creek; thence south-easterly generally along the middle of that creek to the eastern side of Richardson Road; thence along the eastern side of the aforesaid road to its junction with Stoddard Road; thence along a right line across Richardson Road, in the direction of the easternmost corner of Allotment 94, Titirangi Parish, to its intersection with the middle line of Stoddard Road; thence along the middle of Stoddard Road, Sandringham Road Extension, Gifford Avenue, Waite Avenue, and Mount Albert Road, to a point in line with the eastern boundary of Allotment 46, Titirangi Parish; thence northerly generally to and along that eastern boundary and the eastern boundaries of Allotments 178, 146, 145, 144, 143, 142, 141, 140, 139, 138, and part 137, all of Section 10, Suburbs of Auckland, and the eastern side of Cricket Avenue to the southern boundary of Allotment 12, of Section 10, Suburbs of Auckland; thence along that boundary to its intersection with the production of the western boundary of a subdivision of part Allotment 11, Section 10 aforesaid, as shown on Deeds Plan 47; thence along a right line to and along the western boundary of the aforesaid subdivision to a right line distant 235 links south-easterly from and parallel to New North Road; thence along that right line to Dominion Road, and along another right line across that road to the westernmost corner of Allotment 2F of Section 10, Suburbs of Auckland; thence along the eastern side of Dominion Road to a point in line with the north-eastern boundary of Allotment 10 of Section 5, Suburbs of Auckland; thence north-westerly to and along that north-eastern boundary to the northernmost corner of the aforesaid allotment; thence south-westerly generally along the boundary of the Electoral District of Grey Lynn, hereinbefore described, to the point of commencement.

EDEN

All that area bounded by a line commencing at a point in the middle of Broadway in line with the production of the middle line of Carlton Gore Road; thence southerly generally along the middle of Broadway, to and along the middle of the North Auckland Main Trunk Railway to the south-western boundary of Allotment 23, Section 4, Suburbs of Auckland; thence along the south-western boundary of the said Allotment 23, to and along the south-eastern boundary of part Allotment 24, Section 4, aforesaid, comprised in certificate of title, Volume 75, folio 256, Auckland Registry, and the production of the south-western boundary of the said part Allotment 24 to a point distant 278 links easterly from Broadway; thence along a right line parallel to Broadway to a point in line with the northern side of Mortimer Pass; thence to and along that northern side and the western side of Broadway and Manukau Road to the north-eastern corner of Allotment 36, Section 10, Suburbs of Auckland; thence westerly generally along the northern boundary of Allotment 36, Section 10 aforesaid, and its production across The Drive to its western side; thence along the western side of The Drive, to and across the abutment of Heywood Crescent, and again along the western side of that drive, to and along the northern side of Selwyn Road, to and across the abutment of Coronation Road, and again along the northern side of Selwyn Road, to and along the eastern side of St. Andrews Road, to and along the northern side of Landscape Road to a point distant 1,356 links from St. Andrews Road; thence along a right line to a point on the southern side of Landscape Road distant 1,356 links from St. Andrews Road; thence along the southern side of Landscape Road aforesaid, to and along the western boundary of Lot 4 of Allotment 79, Section 10, aforesaid, and the northern boundary of Allotment 80, Section 10, aforesaid, to the north-eastern side of Three Kings Road; thence along the aforesaid north-eastern side to a point in line with the southern boundary of part Lot 2, D.P. 18660, being part of Allotment 92 of Section 10, Suburbs of Auckland; thence along a right line across the aforesaid Three Kings Road, to and along the southern boundaries of the aforesaid part Lot 2, Lots 1 and 2, D.P. 39849, and Lots 5, 4, and 3, D.P. 41970, the aforesaid lots all being parts of Allotment 92 of the said Section 10, to the north-eastern corner of Lot 169, D.P. 37709, being part Allotment 91 of Section 10, Suburbs of Auckland; thence along the northern boundary of Allotment 91 of the said Section 10, to and across Parau Road, to and along the northern boundary of Allotment 116 of Section 10 aforesaid, to a point distant 339.4 links easterly from the eastern side of Dominion Road; thence along the eastern and part of the northern boundaries of part Allotment 115, Section 10, aforesaid, to and along the eastern boundaries of Lots 14 and 13 of Allotment 115 aforesaid, the eastern boundaries of parts of Allotment 115 aforesaid, and the eastern and part of the northern boundaries of Lot 12 of Allotment 115 aforesaid to the south-eastern corner of Lot 2 of Allotment 115 aforesaid; thence along the eastern boundaries of Lots 11 and 1 of Allotment 115 aforesaid to a point on the southern side of Landscape Road, distant 200 links from Dominion Road, the aforesaid subdivisions of Allotment 115 of Section 10, Suburbs of Auckland, being as shown on Deeds Plan 550, Auckland Registry; thence along the southern side of Landscape Road, to and along a right line across Dominion Road, to and along the northern boundary of Allotment 125 of Section 10 aforesaid to the eastern boundary of Allotment 46, Titirangi Parish; thence northerly and easterly generally along the boundaries of the Electoral Districts of Mount Albert and Auckland Central, hereinbefore described, to the point of commencement.
