

ROSKILL

All that area bounded by a line commencing at the north-eastern corner of Allotment 36 of Section 10, Suburbs of Auckland, on the western side of Manukau Road; thence along the production of the northern boundary of the aforesaid allotment to the middle of Pah Road; thence southerly along the middle of Pah Road to a point in line with the southern side of Mount Albert Road; thence westerly along that southern side to the western boundary of Lot 5 of a subdivision of Allotments 3 and 5 of Section 13, Suburbs of Auckland; thence southerly generally along the western and southern boundaries of the said Lot 5, the southern boundary of Lot 9 of a subdivision of Allotment 3 of Section 13, Suburbs of Auckland, to the north-western corner of Lot 10 of a subdivision of Allotments 3 and 4 of Section 13, Suburbs of Auckland; thence along the western boundary of the said Lot 10 and its production to and along the northern and western boundaries of Lot 13 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, the western boundaries of Lots 14 and 15 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, and Lots 19 and 20 of a subdivision of Allotment 4 of Section 13, Suburbs of Auckland, to and along the north-eastern boundary of Lot 7, the north-eastern and north-western boundaries of Lot 8, both lots being of Block XII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland, to and across Carlton Street, to and along the south-eastern boundary of Lot 9 of Block XII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland (being a recreation reserve), the north-western boundaries of Lots 8 and 7 of Block XIII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland, and the production of the north-western boundary of the said Lot 7 to the middle of Belfast Road; thence along the middle of Belfast Road and the western side of Frederick Street to the shore of Manukau Harbour; thence westerly along the shore of Manukau Harbour to a point in the middle of Lewis Street; thence northerly and easterly generally along the boundaries of the Electoral Districts of New Lynn, Mount Albert, and Eden, hereinbefore described, to the point of commencement.

REMUERA

All that area bounded by a line commencing at a point on the seaward side of Tamaki Drive due north of Point Resolution; thence southerly generally along the boundaries of the Electoral Districts of Auckland Central, Eden, and Roskill, hereinbefore described, to the intersection of the middle line of Pah Road with the southern side of Mount Albert Road; thence easterly along the southern side of Mount Albert Road to its intersection with the production of the south-eastern side of Campbell Road; thence northerly along a right line to the intersection of the north-western side of Campbell Road with the eastern side of Manukau Road; thence along that eastern side to the southernmost corner of Lot 1, D.P. 4094; thence north-easterly along the south-eastern boundaries of the said Lot 1, Lots 12, 13, 14, 15, 16, 17, 18, 19, and 20 on D.P. 21888, Lots 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, and 28 on D.P. 19833, and Lots 1, 2, 3, 4, 5, and 6 on D.P. 21889, to the south-western boundary of Cornwall Park as shown on D.P. 2439; thence south-easterly along the boundary of Cornwall Park to Campbell Road; thence north-easterly along the north-western side of Campbell Road to a point in line with the north-eastern side of Moana Avenue; thence along a right line to the intersection of the north-eastern side of Moana Avenue with the south-eastern side of Campbell Road; thence along the south-eastern side of Campbell Road to Great South Road; thence along a right line to a point on the line between Standard Survey Blocks M. 753 (Great South Road) and M. 752 (Wairakei Street) and distant 113 links from the first-mentioned standard; thence north-easterly along a right line to the south-western corner of Allotment 25, Section 12, Suburbs of Auckland; thence along the generally southern boundaries of Allotments 25, 34, 12A, and 26A, Section 12, Suburbs of Auckland, and the production of the last-mentioned boundary to the middle of Ballarat Street; thence northerly generally along the middle of Ballarat Street, Whitley Avenue, College Road, and St. John's Road to the Auckland-Westfield Railway; thence westerly along the northern side of the said railway to Purewa Creek; thence along the right bank of Purewa Creek and north-westerly along the shore of Hobson Bay to and across Tamaki Drive at Hobson Point; thence westerly along the seaward side of Tamaki Drive to the point of commencement.

TAMAKI

All that area bounded by a line commencing at a point on the seaward side of Tamaki Drive due north of Hobson Point; thence easterly and southerly generally along the shore of Waitemata Harbour and up the left bank of the Tamaki River to a point in the middle line of Point England Road; thence westerly generally along the middle of Point England Road, Riverside Avenue, Anderson Avenue, Pilkington Road, and again Point England Road to the north-eastern side of the Auckland-Westfield Loop Railway; thence north-westerly generally along the north-eastern side of the said railway to its intersection with the middle line of St. Johns Road; thence along the boundary of the Electoral District of Remuera, hereinbefore described, to the point of commencement; and including all wharves and other extensions seaward.

ONEHUNGA

All that area bounded by a line commencing at the intersection of the middle of the North Island Main Trunk Railway and the right bank of Anns Creek; thence southerly along the middle of that railway and north-easterly generally along the middle of the Auckland-Westfield Loop Railway to the middle of Waipuna Road; thence westerly and north-easterly generally along the middle of Waipuna Road, Mount Wellington Highway, Penrose Road, Panorama Road, Ferndale Road, Ellerslie-Panmure Highway, Burt Road, Marua Road, Harding Avenue, and Gollan Road to the end of the last-mentioned road; thence north-westerly along the end of Gollan Road, to and along the north-eastern boundary of Lot 208, D.P. 32675, being part Allotment 51 of Section 12, Suburbs of Auckland, along the north-eastern boundaries of Lots 6, 5, 4, 3, and 2 on D.P. 25097, being parts of Allotments 51 and 52, Section 12 aforesaid, the north-eastern boundary of another part of Allotment 52, and along the production of the last-mentioned boundary to the middle of College Road; thence south-westerly generally along the boundary of the Electoral District of Remuera, hereinbefore described, to the intersection of the middle line of Pah Road with the southern side of Mount Albert Road; thence southerly
