Station "Q", Davidsons Top, in Run 656, to the eastern boundary of Run 658; thence generally south-westerly along the summit of the said leading ridge and generally south-easterly along the summit of the Lammerlaw Range to Trig. Station "F", Hedgehope Survey District; thence north-easterly along a right line to the opposite road angle; thence north-easterly along the north-western side of a road to the northernmost angle of a road intersection at peg VII as shown on S.O. Plan 615; thence south-easterly along a right line to the easternmost angle of that road intersection; thence generally south-easterly along the north-eastern side of a road to the generally northern boundary of Run 659; thence generally south-easterly along the north-eastern side of an undefined road intersecting that Run 659 to a point on the south-eastern boundary of the said Run 659, distant 250 links approximately north-easterly from peg XXII, S.O. Plan 632; thence north-easterly along the south-eastern boundaries of Runs 659 and 660 to the north-eastern side of an undefined road intersecting Runs 660 and 661; thence south-easterly along the north-eastern side of that road to the eastern boundary of that Run 661; thence generally easterly, south-easterly, and north-easterly along the northern, north-eastern, and north-western sides of an undefined road forming the southern boundary of Run 186B and intersecting Run 186C and the said Run 186B to peg 12, S.O. Plan 900; thence generally north-westerly along the north-eastern boundary of Run 186B to the south-western boundary Run 186A; thence north-easterly along the north-western side of an undefined road intersecting Run 186A to the north-eastern boundary of that Run 186A; thence generally south-easterly to and along the south-western boundaries of Run 260B and Section 24, Block III, Lee Stream Survey District, to the southernmost corner of that Section 24; thence generally south-easterly down the middle of Lee Stream to a point in line with the western boundary of Block XI, Waipori Survey District; thence southerly to and along the western boundaries of that block and Block XII, Waipori Survey District, to the point of commencement, excluding the Borough of Tapanui hereinbefore described, the Borough of Lawrence as described in *Gazette*, 1877, page 527, and the Borough of Roxburgh as described in *Gazette*, 1882, page 132.

All that area in Tuapeka County bounded by a line commencing at the westernmost corner of Section 26, Block V, Greenvale Survey District, and proceeding north-easterly along the south-eastern side of Moncurs Road to the westernmost corner of Lot 1, D.P. 3814; thence due east to and along the southern boundaries of Sections 24 and 25, Block IV, Greenvale Survey District, and the production of the southern boundary of that Section 25 to the north-eastern side of Shanks Road; thence easterly along the northern boundary of Section 11, Block IV aforesaid, and its production to the south-eastern side of the road forming the north-western boundaries of Sections 9 and 8, Block IV aforesaid; thence south-westerly along that south-eastern side of that road to the northern side of Mill Road; thence easterly and south-easterly along the northern and north-eastern sides of that road to the western boundary of Section 1, Block II, Crookston Survey District; thence southerly along the western boundary of that Section 1 and generally easterly along the southern boundaries of that Section 1 and Sections 2, 3, and 4 and the production of the southern boundary of Section 4 to the south-western boundary of Section 6, Block II aforesaid; thence south-easterly along that boundary and the south-western boundary of Section 7, Block II aforesaid, to the southernmost corner of that Section 7; thence south-easterly to and along the south-western boundaries of Sections 6 and 5, Block III, Crookston Survey District, to the southernmost corner of that Section 5; thence south-easterly along a bearing of 159° 58' to the westernmost corner of Lot 7, D.P. 1329; thence south-easterly along the south-western boundaries of Lots 7 and 6, D.P. 1329, to the north-western boundary of Section 3, Block X, Crookston Survey District; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of that section to the southernmost corner of Lot 6, D.P. 1329; thence north-easterly along the south-eastern boundary of that Lot 6 and due north along the eastern boundaries of Lots 5, 4, 3, and 2, D.P. 1329, and the production of the eastern boundary of that Lot 2 to the southern boundary of Section 2, Block XI, Crookston Survey District; thence generally easterly along that boundary and easterly and north-easterly along the southern and south-eastern boundaries of Section 3, Block XI aforesaid, and the production of the last-mentioned boundary to the eastern boundary of that Block XI; thence due south along the western boundaries of Blocks XIX and XX, Crookston Survey District, to the northern boundary of Rankleburn Survey District; thence southerly along a right line to the middle of the Rankleburn at the intersection of the middle of that stream with the southern boundary of Block VII, Rankleburn Survey District; thence generally south-westerly and south-easterly down the middle of the Rankleburn and its production to the middle of the Pomahaka River; thence generally south-westerly and north-westerly along the south-eastern and south-western boundaries of the County of Tuapeka hereinbefore described to a point due

south of the easternmost corner of Lot 4, D.P. 2427; thence due north to that corner; thence north-westerly along the north-eastern boundary of that Lot 4 to a point in line with the north-western boundary of Original Section 48, Block II, Greenvale Survey District; thence north-easterly to and along that boundary and the north-western boundaries of Original Sections 13 and 12, Block II aforesaid, to the northernmost corner of Lot 1c, D.P. 2427; thence north-easterly along the north-western boundary of Section 3s, Kelso Settlement, and its production to the north-eastern side of Park Hill-Kelso road; thence generally north-westerly along the north-eastern side of that road to the point of commencement, excluding the Borough of Tapanui hereinbefore described.

BOUNDARIES OF COUNTY OF STRATFORD

ALL that area in the Taranaki Land District bounded by a line commencing at a point being the summit of Mount Egmont; thence easterly along a right line to the intersection of the west side of Forest Road and the Waipuku Stream; thence down the middle of the Waipuku Stream to its confluence with the Manganui Stream, and up the middle of that stream to the northern boundary of Block IX, Huiroa Survey District; thence easterly and southerly along the northern and eastern boundaries of Block IX, Huiroa Survey District, to Croydon Road; thence generally easterly along the northern side of Croydon Road to the south-eastern corner of Section 11, Block X, Huiroa Survey District; thence northerly along the eastern boundary of the said Section 11 to the southern boundary of Section 14, Block X, Huiroa Survey District; thence easterly along the said southern boundary of Section 14 to the western side of the Mangaotea Road; thence southerly along the western side of that road to a point in line with the southern boundary of Section 20, Block X, Huiroa Survey District; thence to and easterly along the southern boundary of the said Section 20; thence southerly and easterly along the western and southern boundaries of Section 26, Block X, Huiroa Survey District, to the Makara Road; thence northerly along the western side of the Makara Road to a point in line with the southern boundary of Section 28, Block X, Huiroa Survey District; thence to and easterly along the southern boundary of the said Section 28 to the eastern boundary of Block X, Huiroa Survey District; thence southerly along the said eastern boundary of Block X to the middle of the Makino Stream; thence generally easterly along the middle of the Makino Stream to the eastern boundary of Section 5, Block XI, Huiroa Survey District; thence northerly along the said boundary of Section 5 to the middle of the Makara Road; thence generally northerly along the middle of the Makara and Mana Roads to the northern boundary of Block XI, Huiroa Survey District; thence generally easterly along the northern boundaries of Blocks XI and XII, Huiroa Survey District, to the middle of the Makino Stream; thence down the middle of the Makino Stream to the Waitara River; thence down the middle of the Waitara River to a point in line with the western boundary of Section 9, Block VIII, Huiroa Survey District; thence to and generally northerly and easterly along the western and northern boundaries of Section 9 and 13, Block VIII, Huiroa Survey District, and northerly along the western boundaries of Sections 18 and 19, Block V, Ngatimaru Survey District, to the Pita Road; thence across that road and easterly generally along its northern side to the westernmost corner of Section 14, Block I, Ngatimaru Survey District; thence generally easterly along the southern boundaries of Sections 14 and 13, Block I, aforesaid, to the southernmost point of the last-mentioned section; thence by a right line direct to the middle of the Waitara River; thence up the middle of that river to a point in line with the western boundary of Section 1, Block X, Upper Waitara Survey District; thence to and generally northerly and easterly along the western and northern boundaries of the said Section 1 and its production to the middle of the Waitara River; thence generally easterly and northerly up the middle of the Waitara River to a point in line with the western boundary of Section 2, Block XVI, Upper Waitara Survey District; thence by a right line to the north-western corner of the said Section 2; thence generally easterly and northerly by the eastern side of the Waitara Valley Road and the Rerekino Road to the southern boundary of Section 3, Block VIII, Upper Waitara Survey District; thence generally easterly by the southern boundaries of Section 3 and part Section 4, Block VIII, Upper Waitara Survey District, and generally easterly and northerly by the southern and eastern boundaries of Sections 5, 6, and 7, Block V, Pouatu
