

of the western boundary of Lot 2 of Section 3, Block II aforesaid, and the northern side of that road; thence due north to the said intersection; thence northerly along the western boundary of the said Lot 2 of Section 3 aforesaid and its production to the middle of the Ruatiti Stream; thence northerly up the middle of that stream to a point in line with the southern boundary of Section 8, Block XIII, Kaitieke Survey District; thence westerly generally to an along that boundary and the south-western boundary of that section and its production to the middle of Kokako Road, along the middle of that road to a point in line with the south-western boundary of Section 5, Block XIII aforesaid, to and along that boundary and the south-western boundary of Lot 1 of Section 3, the south-eastern boundary of Section 9, Block XIII aforesaid, and its production to the middle of the Maungaroa Road and along the middle of that road to a point in line with the northern boundary of Section 3, Block IV, Whirinaki Survey District; thence westerly generally along the northern boundaries of Blocks IV, III, II, and I, Whirinaki Survey District, to the middle of the Wanganui River; thence up the middle of that river to a point in line with the northern boundary of Maraekowhai A 3 B 2 Block; thence westerly and southerly to and along the northern and western boundaries of that block and the western boundary of Maraekowhai A 3 B 1 Block to the northern boundary of Section 5, Block X, Heao Survey District; thence westerly generally along the northern boundary of that section and the northern boundary of Section 2, Block IX, Heao Survey District, and its production across Heao Road to the middle of the Heao Stream; thence northerly generally up the middle of that stream to the 39th parallel of south latitude; thence westerly along the said 39th parallel to a point in line with the western boundary of Block XVI, Waro Survey District; thence northerly along a right line to and along the western boundary of the aforesaid Block XVI, Waro Survey District, to the confiscation boundary line; thence along that line to the Tangarakau Stream; thence generally northerly along that stream and the Waitaanga Stream to the Kotare Road at the southern boundary of Section 2, Block VII, Waro Survey District; thence generally westerly along the Kotare Road and the southern boundaries of Section 1, Block VII, and Section 3, Block VI, Waro Survey District, to the south-western corner of the last-mentioned section; thence generally northerly along the western boundaries of Sections 3, 4, 5, and 6, Block VI, Waro Survey District, to the north-western corner of the said Section 6; thence easterly along the northern boundary of the said Section 6 to the Mohakatino Road; thence northerly along the Mohakatino Road to the Mangaone Stream and down the said stream to the point nearest the source of a stream intersecting the Mohakatino-Parinihi 1b Block; thence along a right line to and down the said stream to its confluence with the Mohakatino Stream near the westernmost corner of Section 1, Block III, Waro Survey District; thence up the Mohakatino Stream and easterly along the northern boundary of Section 7, Block III, Waro Survey District, to Tawhitiraupaka Trig. Station; thence generally northerly along the western boundary of the Mokau-Mohakatino 1h Block and its production to the middle of the Mokau River; thence up the middle of that river to its confluence with the Panirau Stream; thence up the middle of the Panirau Stream to the western boundary of Aria Survey District; thence northerly along that boundary to the south-western corner of Section 11, Block V, Aria Survey District; thence easterly and northerly along the southern and eastern boundaries of the said Section 11 to the south-western corner of Section 2, Block V, Aria Survey District; thence easterly along the southern boundaries of the said Section 2 and Section 3 and southerly and easterly along the western and southern boundaries of Section 8 all of Block V, Aria Survey District, and the last-mentioned boundary produced to the middle of the Waitewhena Road; thence northerly along the middle of that road to a point in line with the southern boundary of Section 15, Block VI, Aria Survey District; thence generally easterly along the southern boundaries of Sections 15 and 6, Block VI, Aria Survey District; thence generally southerly along the western boundary of Section 9, Block VI, Aria Survey District, to the southern boundary of Block VI, Aria Survey District; thence generally north-easterly along the southern and eastern boundaries of Block VI, Aria Survey District, and generally easterly along the southern boundaries of Blocks III and IV, Aria Survey District, and Blocks I and II, Tangitu Survey District, to the south-eastern corner of Section 18, Block II, Tangitu Survey District; thence north-easterly along the south-eastern boundary of Section 18 aforesaid, to and easterly along the southern side of Takiri Road to and across Paraketu Road, and again easterly along the southern side of Takiri Road to a point in line with the eastern side of a public road intersecting part Section 2, Block III, Tangitu Survey District; thence across Takiri Road and generally easterly along its northern side to, and northerly along the eastern boundary of Rangitoto-Tuhua 77b 1b 1; thence north-easterly along the north-western boundaries of Rangitoto-Tuhua 77b 1b 2c 2b and 77b 1b 2b, and north-westerly along the south-western boundary of part Rangitoto-Tuhua 78b 2f to the south-western corner of Lot 1, D.P. 7475 (Taranaki Land Registry), being a point on the southern boundary of Block XIII, Mapara Survey District; thence easterly along the southern boundaries of Blocks XIII and XIV, Mapara Survey District, and northerly along the eastern boundary of the said Block XIV to and easterly along the northern boundary of Subdivision 1 of Section 2, Block III, Pahi Survey District, northerly along the western boundary of Rangitoto-Tuhua 37b 1 Block and northerly and easterly along the western and northern

boundaries of part Rangitoto-Tuhua 37b 5 Block and easterly along the northern boundary of Rangitoto-Tuhua 37b 4 Block, the northern and eastern boundaries of Rangitoto-Tuhua 37b 3 Block, the northern boundaries of Rangitoto-Tuhua 36a 1b 2b 1, and 36a 1b 2b 2a Blocks, the northern and eastern boundaries of Rangitoto-Tuhua 36a 1b 2b 2b Block, the eastern boundary of Rangitoto-Tuhua 54a 2 Block, and its production to the middle of the Ongarue River; thence easterly generally up the middle of that river to its source; thence along a right line to the point of commencement; excluding therefrom the Borough of Taumarunui as described in *Gazette*, 1959, page 1515, and the Town District of Ohura as described in *Gazette*, 1925, page 1.

#### BOUNDARIES OF TOKIRIMA RIDING

All that area in the Taranaki Land District, comprising portion of the Taumarunui County, bounded by a line commencing at a point in the middle of the Panirau Stream at its intersection with the western boundary of Block IX, Aria Survey District, being a point on the boundary of the Taumarunui County as hereinbefore described and proceeding generally westerly, southerly, and easterly by the northern, western, and southern boundaries of that county to the middle of the Wanganui River; thence up the middle of that river to the southern boundary of Block VIII, Heao Survey District; thence north-westerly along the south-western boundaries of the said Block VIII and Block III, Heao Survey District, and the south-western boundary of Koiro 5c Block to and northerly along the western boundary of that block across Koiro Road to and again northerly along the western boundary of Koiro 5c Block across Koiro Road to and northerly along the western boundaries of Koiro 5c and part Koiro 5b and the western boundary of Lot 1, D.P. 7329, across Kaikara Road and again northerly along the western boundary of part Koiro 5a Block to its north-western corner; thence generally easterly along the northern boundary of part Koiro 5a Block and the northern boundary of Koiro 4a Block crossing Otuiti Road to the western boundary of Section 1, Block III, Heao Survey District; thence northerly along that boundary to the southern boundary of Block XV, Ohura Survey District; thence westerly across Otuiti Road along the southern boundary of that block to the western boundary of Lot 1, D.P. 6343; thence northerly along the western boundary of that lot and its production to the middle of the Ohura River; thence easterly and northerly generally up the middle of that river to a point in line with the western boundary of Section 7, Block XI, Ohura Survey District; thence northerly and easterly to and along the western and northern boundaries of the said Section 7 and Section 13 and again northerly and easterly along the western and northern boundary of Section 8 all of Block XI, Ohura Survey District, to Mona Trig. Station; thence northerly along the western boundary of Subdivision 2 of Section 9, Block XI, Ohura Survey District, and easterly generally along the northern boundaries of the said Subdivision 2 and Subdivision 1 of Section 9 and the northern boundary of Lot 3, D.P. 4065, to the south-western boundary of Section 1, Block XII, Ohura Survey District; thence north-easterly along the south-western boundary of that section and easterly along the northern boundaries of the said Section 1 and Section 3, Block XII, Ohura Survey District, to the western boundary of Section 4, Block VIII, Ohura Survey District; thence northerly along the western boundaries of that section and Section 2, Block VIII, to Ararimu Road; thence westerly along the southern side of that road to a point in line with the western boundary of Section 12, Block VIII, Ohura Survey District; thence across Ararimu Road and westerly along its northern side to a point due north of the intersection of the southern side of that road with the northern boundary of Section 9, Block VII, Ohura Survey District; thence to and westerly along the northern boundary of that section, to and along the north-eastern boundary of Section 6, Block VII aforesaid, to the northern boundary of the said Block VII; thence south-westerly along that boundary to the eastern bank of the Ohura River; thence southerly down the eastern bank of that river to a point in line with the northern boundary of Section 1, Block VI, Ohura Survey District; thence easterly to and along that boundary and southerly along the eastern boundary of that section to the western side of Turoto Road; thence southerly along the western side of that road and its production to the middle of the Ohura River; thence westerly generally up the middle of that river to a point in line with the eastern boundary of Section 4s, Huia Settlement; thence southerly to and along the eastern boundary of that section and westerly along its southern boundary to the northern side of Huia Road; thence westerly and northerly along the northern side of that road to its intersection with the western boundary of Block VI, Ohura Survey District; thence northerly along the western boundary of the said Block VI to Ohura Road; thence generally north-easterly along the south side of that road for a distance of about 12½ chains; thence along a right line across that road to and across the Waitewhena Stream, along the right bank of that stream, to and along the left bank of the Mangakara Stream, to a point in line with the eastern boundary of Section 2, Block V, Ohura Survey District, and thence along a right line to the north-eastern corner of that section; thence westerly along the northern boundary of the said Section 2 and Section 16, Block V aforesaid, crossing the Provincial State Highway No. 40 to a point in line with the eastern boundary of Section 13, Block V aforesaid; thence northerly to and along that boundary and the eastern boundaries of
