NOTICE is hereby given that the Wellington City Council proposes under the provisions of the above-named Acts and all other Acts, powers, and authorities enabling it in that behalf to execute a certain public work, namely for housing purposes at Nairn Street and Brooklyn Road in the City of Wellington and for the purposes of that public work the land described in the Schedule hereto is required to be taken.
