PURSUANT to section 128 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby approves of the resolution passed by the Newmarket Borough Council on the 9th day of July 1963, and set out in the First Schedule hereto, in so far as it affects the side and portion of street described in the Second Schedule hereto.

FIRST SCHEDULE

NORTH AUCKLAND LAND DISTRICT

THE Newmarket Borough Council being the local authority having control of the streets in the Borough of Newmarket, by resolution declares that the provisions of section 128 of the Public Works Act 1928 shall not apply to that portion of Short Street fronting Lot 15 of Section 1 of subdivision of Allotments 39 and 40; and Lots 16 and 17, D.P. 5150 and part Lot 1, D.P. 23481, being part Allotment 40, Section 3, Suburbs of Auckland, comprised in certificates of title, Volume 7, folio 35 and Volume 732, folio 7, North Auckland Land Registry.
