##### *Waterworks Redemption Loan 1963 of £3,900*

THE following resolution was duly passed at a special meeting of the Henderson Borough Council held on the 22nd day of July 1963:

Pursuant to the Local Authorities Loans Act 1956, the Henderson Borough Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on the loan of £3,900 authorised to be raised by the Henderson Borough Council under the above-mentioned Act for the purpose of repaying on maturity that portion of the Waterworks Additional Loan 1953 of £5,500 which matured on 3 July 1963, the said Henderson Borough Council hereby makes a special rate of decimal zero nine pence (0.09d.) in the pound on the rateable unimproved value of all rateable property in the Borough of Henderson; and that such special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of June in each and every year during the currency of the loan, being a period of 15 years, or until the loan is fully paid off; and that such special rate is hereby permanently appropriated and pledged as security for the purpose of securing the said loan of £3,900 and interest thereon at the rate of five and three-eighths per cent (5 $\frac{3}{8}$  per cent) per annum."
