"That, for the purpose of providing the annual charges on a loan of twenty-four thousand pounds (£24,000) authorised to be raised by the South Canterbury Electric Power Board under the above-mentioned Act for the purpose of repaying on maturity that portion of the Electricity Development Loan 1957 which matures on 1 March 1964, the said South Canterbury Electric Power Board hereby makes a special rate of fifteen thousandths of one penny (0·015d.) in the pound (£1) upon the rateable value (being the capital value) of all rateable property within the South Canterbury Electric Power District as defined in the Third Schedule to the Proclamation dated 23 August 1957 and published in the Gazette on 29 August 1957, at page 1575; and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of March in each and every year during the currency of the loan, being a period of eight years, or until the loan is fully paid off."
