

Reservation of Land and Declaration That Land be Part of the Opunake Domain

Licensing Norman Joseph Liddicoat to Use and Occupy a Part of the Foreshore and Bed of the Sea at Flat Point as a Site for a Slipway

Amending Licence Authorising the Manapouri - Doubtful Sound Tourist Co. Ltd. to Use and Occupy Parts of the Bed of Lake Manapouri and of the Foreshore and Bed of the Sea in Doubtful Sound as Sites for 12 Jetties and Two Slipways
