## RESOLUTION MAKING SPECIAL RATE

THAT, in pursuance and exercise of the powers vested in it in that behalf by the Counties Act 1956 and amendments, the Local Authorities Loans Act 1956 and amendments, and the Rural Housing Act 1939 and amendments and regulations thereunder, and all other powers thereunto enabling it, the Horowhenua County Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of twelve thousand pounds (£12,000) authorised to be raised by the Horowhenua County Council under the above-mentioned Acts for the purpose of making advances to farmers in terms of the Rural Housing Act 1939, the said Horowhenua County Council hereby makes a special rate of decimal nought three two pence (0.032d.) in the pound upon the rateable value (on the basis of the unimproved value) of all rateable property in the County of Horowhenua; and that the special rate shall be an annually recurring rate during the currency of the loan and be payable yearly on the 1st day of April in each and every year during the currency of the said loan or until the loan is fully paid off."

*Sewerage Mains Extension Loan 1963, £95,000*

IN pursuance and exercise of the powers vested in it in that behalf by the Local Authorities Loans Act 1956 and all other Acts and powers enabling it in that behalf, the Blenheim Borough Council doth hereby resolve as follows:

"That, for the purpose of securing the interest and other charges on a loan of ninety-five thousand pounds (£95,000) authorised to be raised by the Blenheim Borough Council under the above-mentioned Act for providing sewerage reticulation in portions of the Borough, the said Council hereby makes and levies a special rate of five hundred and twenty-one one-thousandths of a penny (0.521d.) in the pound (£) on the unimproved rateable value of all rateable property within the Borough of Blenheim; and that such special rate shall be an annually recurring rate payable on demand in each and every year during the currency of the said loan, being a period of twenty-five (25) years, or until the said loan is fully paid off; and the said Council doth hereby appropriate and pledge the said special rate as security for the above loan."
