ORDER

1. This order may be cited as the Abilities (North Shore)
Incorporated Order 1963.

2. Exemption is hereby granted to Abilities (North Shore)
Incorporated, an organisation approved by the Minister of
Labour under section 3 of the Disabled Persons Employment
Promotion Act 1960, in respect of the sheltered workshop
controlled by that organisation at Barry's Point Road,
Takapuna, from:

- (a) All the provisions of every award and industrial agree-
ment which would otherwise be applicable in respect
of persons employed in that workshop; and
- (b) All the provisions of the Annual Holidays Act 1944
and the Minimum Wage Act 1945.

ORDER

1. This order may be cited as the Disabled Citizens' Society
(Incorporated) Order 1963.

2. Exemption is hereby granted to the Disabled Citizens'

Minister of Labour under section 3 of the Disabled Persons
Employment Promotion Act 1960, in respect of the sheltered
workshop at Dominion Road, Auckland, controlled by the
said organisation, from:

- (a) All the provisions of every award and industrial agree-
ment which would otherwise be applicable in respect
of persons employed in that workshop; and
- (b) Section 34 of the Factories Act 1946 and all the pro-
visions of the Annual Holidays Act 1944 and the
Minimum Wage Act 1945.

ORDER

1. On and from the 1st day of April 1964 the area described
in the First Schedule hereto is hereby excluded from the
Borough of Havelock North and included in the County of
Hawke's Bay.

2. On and from the date aforesaid the area described in
the Second Schedule hereto is hereby excluded from the
County of Hawke's Bay and included in the Borough of
Havelock North.

3. The alteration of the boundaries of the said county and
the said borough hereinbefore made shall be deemed to
have been effected under the Municipal Corporations Act
1954.

AREA EXCLUDED FROM BOROUGH OF HAVELOCK NORTH AND
INCLUDED IN COUNTY OF HAWKE'S BAY

ALL that area in the Hawke's Bay Land District, Borough of
Havelock North, containing 17.6 perches, more or less, being
Lots 5 and 6, D.P. 10283, being part Block 9, Te Mata
Crown Grant District.

SECOND SCHEDULE
