Varying Notice of Declaration of State Highways

PURSUANT to section 11 of the National Roads Act 1953, the National Roads Board, acting with the written approval of the Minister of Works, hereby gives notice that it varies the notice declaring highways to be State highways, dated 9 March 1960, published in the *Gazette*, 24 March 1960, Vol. I, No. 20, page 384, by deleting from Part II of the Schedule to the said notice the paragraph described in the First Schedule hereto and submitting therefor the paragraphs set out in the Second Schedule hereto.

No. 2 State Highway. From the Western Boundary of Napier City along Meeanee Quay over the Westshore Bridge along Pandora Road, Hyderabad Road, Thackeray Street, Munroe Street, Hastings Street, Warren Street, and Marine Parade to the south-eastern boundary of the city at Ellison Street.

No. 50 State Highway. Commencing in Napier City at the junction of Hyderabad Road and Taradale Road on No. 2 State Highway along Taradale Road to the south-western boundary of the city.

Return of Spirits Distilled in New Zealand
