S. 1621, and along the southern boundary of part Otorohanga 2c 2b to its south-western corner; thence south-easterly along a right line, to and along the western boundary of Section 17, Block III, Orahiri Survey District, to and westerly generally along the north-western boundary of Section 8, the north-western and western boundaries of Section 9, the generally northern boundary of Section 30, along a right line across a public road, to and along the north-eastern and north-western boundaries of Section 26 and the north-western boundary of Section 27, all the aforesaid sections being of Block III, aforesaid, to and along the northern boundary of Section 2 and that boundary produced to and southerly along the middle of Tapuae Road to a point in line with the northern boundary of Section 1, both the aforesaid sections being of Block VI, Orahiri Survey District; northern side of Karamu Limeworks Road and along a right line across that road, to and along the south-western boundaries of Allotment 221, Lot 3, D.P. 31190, Lots 9 and 7, D.P. 31190, to a point in line with the eastern boundary of Allotment 331a in Block XI, Alexandra Survey District; thence along a right line to and along the generally eastern boundary of the said Allotment 331a and along a right line across a public road, to and along the north-eastern and eastern boundaries of Allotment 128a and along the south-eastern boundary of part Allotment 213, along a right line across a public road, to and along the south-eastern boundary of another part Allotment 213, both parts shown on S.O. 2457, along the south-eastern boundaries of Lots 2 and 4, D.P. 28507, along a right line across a public road, to and along the generally southern boundaries of Allotments 227, 241, and 251, crossing two intervening public roads, all the aforesaid allotments being of Pirongia Parish, and the last-mentioned boundary produced to and up the middle of the Waipa River, and again easterly generally along the right bank of the Mangaotama Stream and along the north-western boundaries of Allotments 118 and 119, Ngaroto Parish, shown on S.O. 177, Allotment 358, shown on S.O. 5094, Sheet 8, the eastern boundary of Allotment 297a, being an area of 9 acres 3 roods 17.2 perches, and the north-western and northern boundaries of Allotment 359a, being an area of 3 acres 3 roods 22.3 perches, and both areas shown on S.O. 6688, along a right line across the Ngahina-pouri-Ohaupo Road, to and along the northern boundary of Allotment 364a, being an area of 7 acres 3 roods 27 perches and shown on S.O. 176, all the aforesaid allotments being of Ngaroto Parish, to and along the southern boundaries of Lot 8, D.P. 8600, Lot 2, D.P. 20397, and Lot 2, D.P. 20971, along a right line across McGregor Road, to and along the western, southern, and eastern boundaries of Lot 2, D.P. 24355, and the eastern boundary of Lot 1, D.P. 24355, and along a right line across a public road to its northern side in Block X, Hamilton Survey District; thence easterly along the southern boundary of part Allotment 366, Te Rapa Parish, shown on D.P. 4391, along a right line across the North Island Main Trunk Railway, to and along the north-western and north-eastern boundaries of part Allotment 362, Te Rapa Parish, and the last-mentioned boundary produced to and northerly generally along the middle of the Hamilton-Woodville via New Plymouth State Highway No. 3 to a point in line with the south-eastern boundary of part Allotment 170 shown on D.P. 3764, in Block X, Hamilton Survey District; thence north-easterly generally along a right line, to and along that south-eastern boundary and the south-eastern boundary of another part Allotment 170, and along the generally southern boundary of Allotment 171, along a right line, to and along the southern and eastern boundaries of Allotment 173 and the south-eastern boundary of Allotment 172, the above-said boundaries being of Te Rapa Parish, to and along the southern side of a public road forming the northern boundary of Lot 1, D.P. 29091, to and down the middle of Mystery Stream to the point of commencement. THIRD SCHEDULE

WAITOMO ELECTRIC POWER DISTRICT

ALL that area in the South Auckland and Taranaki Land Districts situated in the Counties of Otorohanga, Waitomo, Taupo, and Waipa and the Boroughs of Te Kuiti and Otorohanga, bounded by a line commencing at Urawitiki Point on the southern entrance to the Kawhia Harbour in Block IX, Kawhia North Survey District, and proceeding easterly generally along the southern shores of the said harbour, to and southerly generally up the middle of the Waiharakeke Stream to a point in line with the northern boundary of part Hauturu West 2b 4c South 2 in Block II, Kawhia South Survey District; thence along a right line to and along the generally northern and western boundaries of the aforesaid 2b 4c South 2, along the northern and western boundaries of Lot 1, D.P. 34238, and the western boundaries of Lot 1, D.P. 12417, and Section 17, Block VI, Kawhia South Survey District, to the south-western corner of the aforesaid section; thence easterly generally along the southern and eastern boundaries of the aforesaid section, to and along the south-eastern boundary of part Section 6, along a right line across a public road, along the south-eastern boundary of Section 16, both sections being of Block VI, Kawhia South Survey District, the south-eastern and north-eastern boundaries of part Taumatotara 1d 2b shown on D.P. 10262, to and along the south-eastern boundary of Taumatotara A 2; along the generally south-western and southern boundaries of Lot 11 shown on D.P. 7460, 7461, and 7462, crossing two intervening public roads, to and southerly along the western boundary of Section 1, Block III, Kawhia South Survey District, and along the western boundaries of Sections 4a and 3, Block VII, Kawhia South Survey District, crossing an intervening public road, to and south-easterly generally along the south-western boundaries of Sections 8 and 9, Block VII, aforesaid, crossing an intervening public road and Section 15, Block XI, Kawhia South Survey District, and the north-eastern and south-eastern boundaries of part Lot 2, D.P. 7844 (Scenic Reserve, *Gazette*, 1914, page 4319),
