HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 439 (5) of the Maori Affairs Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby varies an Order in Council made on 28 October 1959 and published in *Gazette* on 5 November 1959, Volume III, page 1593, and affecting the Maori freehold land known as Kohewhata B Block, by excluding therefrom the area of land set out in the Schedule hereto.
