A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 11th day of April 1962, published in the *Gazette* of 26 April 1962, Volume I, page 663, and registered as No. 526495, Wellington Land Registry, defining the middle line of a road in Blocks II, III, VI, VII, IX, and X, Hautapu Survey District, viz, a

deviation of the Utiku-Mangaweka section of the Awanui-Bluff State Highway, and hereby proclaim and declare that the middle line of a road desired to be constructed over Blocks II, III, VI, VII, IX, and X, Hautapu Survey District, viz, a deviation of the Utiku-Mangaweka section of the Awanui-Bluff State Highway, shall be that defined and set forth in the Schedule hereto; and I also declare that this Proclamation shall affect only the lands situated within the limits of the area bounded by broken red lines shown on the plan marked M.O.W. 18356 referred to in the Schedule hereto.

SCHEDULE

WELLINGTON LAND DISTRICT
