ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of June 1964

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL  
PURSUANT to the Public Works Act 1928 and the Electric Power Boards Act 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

## ORDER

1. This order may be cited as the Te Awamutu Electric Power Board Electric Lines Licence 1964.

2. Subject to the conditions hereinafter set forth, the Te Awamutu Electric Power Board (hereinafter referred to as "the licensee") is hereby authorised to lay, construct, put up, place, and use electric lines within the area described in the First Schedule hereto.

3. The conditions directed to be implied in all licences by the Electrical Supply Regulations 1935 and the Electrical Wiring Regulations 1961 shall be incorporated herein and shall form part of this licence, except in so far as they may be inconsistent with the provisions of this licence.

4. The licensee hereby conferred is subject to compliance by the licensee with the Electrical Supply Regulations 1935, the Electrical Wiring Regulations 1961, the Radio Interference Regulations 1958, and with all regulations made in amendment thereof or in substitution thereof, except in so far as they may be inconsistent with the provisions of this licence.

5. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), and (f) of regulation 21-01 of the Electrical Supply Regulations 1935.

6. This licence shall, unless it is sooner lawfully determined, continue in force until the 31st day of March 1985.

7. The Orders in Council specified in the Second Schedule hereto authorising the licensee to erect and use electric lines are hereby revoked.

*Authorising Kelvyn John Sarginson, of Mount Aurum Station, Queenstown, Farmer, to Use Water for the Purpose of Generating Electricity*BERNARD FERGUSSON, Governor-General  
ORDER IN COUNCIL

At the Government Buildings at Wellington this 15th day of June 1964

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL  
PURSUANT to the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby grants to Kelvyn John Sarginson, of Mount Aurum Station, Queenstown, farmer (hereinafter referred to as the licensee), a licence, subject to the conditions hereinafter set forth, to take and use from Skippers Creek (hereinafter referred to as the said stream), situated in Run Nos. 13, 15, and 16, in the Polnoon and Skippers Creek Survey Districts in the County of Lake, for the purpose hereinafter set forth, a stream of water not exceeding 3 cu. ft. per second at any one time.

## CONDITIONS

## IMPLIED CONDITIONS

1. The conditions directed to be implied in all licences by the Water Power Regulations 1934 and the Electrical Supply Regulations 1935 shall be incorporated in and shall form part of this licence, except in so far as the same may be inconsistent with the provisions hereof.

## LICENCE SUBJECT TO REGULATIONS

2. The licence is issued under the Water Power Regulations 1934, and is subject thereto, and to the Electrical Supply Regulations 1935, the Electrical Wiring Regulations 1961, the Radio Interference Regulations 1958, and to all regulations hereafter made in amendment thereof or in substitution thereof respectively.

## UTILISATION OF WATER AND LOCATION OF HEADWORKS

3. Water shall be used under this licence solely for the purpose of generating electricity and shall be taken from the said stream at a point in Run 13, Skippers Creek Survey District, indicated on the plans marked N.Z.E.D. 630 and 632 deposited in the office of the New Zealand Electricity Department at Wellington.

## GENERAL DESCRIPTION OF WORKS

4. The licensee is hereby authorised, subject to the conditions hereof, to construct, maintain, and use the following works for the purpose of the licence, the positions of the said works being indicated on the said plans:

(a) Headworks consisting of a dam and intake with a pipeline leading to the powerhouse, hereinafter referred to, giving a static head of 98 ft.

(b) A pelton wheel and powerhouse with all necessary equipment for generating electricity situated in Run 13, Skippers Creek Survey District.

(c) A pipeline leading from the said powerhouse back to the said stream.

## SYSTEM OF SUPPLY

5. The system of supply shall be as described in paragraphs (d) and (e) of regulation 21-01 of the Electrical Supply Regulations 1935.

## DURATION OF LICENCE

6. Unless sooner lawfully determined this licence shall continue in force until the 31st day of March 1985.

## RENTAL

7. For the purpose of assessing the rental or annual sum payable in respect of this licence, the present plant is rated at 5 kW.

## NO RIGHT TO WATER CONFERRED

8. Nothing in this licence shall of itself confer upon the licensee any right to water.
