A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby revoke the Proclamation, dated the 23rd day of February 1949, published in *Gazette*, 24 February 1949, Vol. I, page 619, and deposited in the Land Registry Office at Wellington as No. 3990, defining the middle line of portion of the Wellington-Napier via Woodville railway (portion of Rimutaka Tunnel deviation) in so far as it affects Lot 15, D.P. 21952, being part Section 221, Hutt District, Block XIV, Akatarawa Survey District, and being all the land in certificate of title, Volume A 3, folio 1260, Wellington Registry.
