Boundaries of City of Hastings, Borough of Taupo, County of Taupo, County of Hawke's Bay, Tauhara Riding of County of Taupo, and Heretaunga, Petane, and Puketapu Ridings of County of Hawke's Bay Defined

Pursuant to section 26 of the Municipal Corporations Act 1954 and section 16 of the Counties Act 1956, the Secretary for Internal Affairs hereby defines, as set out in the Schedule hereto, the boundaries of the City of Hastings, Borough of Taupo, County of Taupo, County of Hawke's Bay, the Tauhara Riding of the County of Taupo, and the Heretaunga, Petane, and Puketapu Ridings of the County of Hawke's Bay, the previous boundaries having been altered by Orders in Council made on 31 January 1962, 26 September 1962, and 13 February 1963, and published in Gazette, 8 February 1962, No. 10, page 252; Gazette, 4 October 1962, No. 61, page 1613; and Gazette, 21 February 1963, No. 13, page 233, respectively.
