*The Control of Prices (Positive List) Notice 1957, Amendment  
No. 37*

PURSUANT to the Control of Prices Act 1947, the Minister of Industries and Commerce hereby gives the following notice:

1. This notice may be cited as the Control of Prices (Positive List) Notice 1957, Amendment No. 37, and shall be read together with and deemed part of the Control of Prices (Positive List) Notice 1957\* (hereinafter referred to as the principal notice).

2. This notice shall come into force on the day after the date of its publication in the *Gazette*.

3. The principal notice shall cease to apply in respect of the goods set out in the Schedule hereto.

4. The principal notice is hereby consequentially amended by omitting from the Schedule thereto all references to the goods referred to in the Schedule hereto in respect of which, pursuant to clause 3 hereof, the principal notice no longer applies.

*Declaring Land Acquired for a Government Work in Nelson  
City and not Required for That Purpose to be Crown Land*

PURSUANT to section 35 of the Public Works Act 1928, the Minister of Railways hereby declares the land described in the First and Second Schedules hereto to be Crown land subject to the Land Act 1948 as from the 26th day of July 1965.
