SCHEDULE 2

EPARAIMA RIDING

All that area in the Hawke's Bay Land District, Patangata County, bounded by a line commencing at a point on the right bank of the Porangahau River in line with the northeastern boundary of Suburban Section 25, Porangahau, in Block XII, Porangahau Survey District; and proceeding northwesterly to and along that boundary, crossing Hunter Station Road, along the northeastern boundaries of Suburban Sections 8, 62, 63, 64, and 65, Porangahau, to the south-eastern boundary of Rural Section 10, Porangahau; thence southwesterly along that boundary and the south-eastern boundary of Rural Section 11, Porangahau, to the north-eastern boundary of Block 76, Porangahau Crown Grant District; thence north-westerly along that boundary and the south-eastern boundary of Block 76, Porangahau Crown Grant District; thence north-westerly along the original north-western boundary of the said Block 76 (passing through Section 3, Block VII, Porangahau Survey District) to the original south-western boundary of Rural Section 4, Porangahau; thence north-westerly along that boundary (passing through Section 1, Block XI, and Section 4, Porangahau; thence north-westerly along that boundary of Rural Section 1, Block XI, Porangahau Survey District) to the original south-western boundary of Rural Section 4, Porangahau; thence north-westerly along that boundary (passing through Section 1, Block XI, and Section 4, Porangahau; thence north-westerly along that boundary and its production to the right bank of the Porangahau River including the crossing of Waipukurau-Masterton via Porangahau State Highway No. 52; thence up that bank and the right bank of the Mangaorapa Stream to a point in line with the northern boundary of Te Aurere No. 1; thence generally westerly to and along that boundary and the northern boundaries of Section 5 and 4, Block X, Porangahau Survey District, the northern boundary of the said Section 3 to the Trig. Station XII; thence north-westerly generally along the north-eastern boundary of the said Section 3 to the Trig. Station ALL that area in the Hawke's Bay Land District, Patangata where that boundary intersects a right line between the said Trig. 27 and the westernmost corner of Wharawhara Block; thence north-easterly along that boundary, to and down the middle of the Mangawhero Stream, to and up a tributary forming part of the south-eastern boundary of Block 56, Porangahau Crown Grant District, and north-easterly along the south-eastern boundary of the said Block 56 to its intersection with the north-eastern boundary of Lot 1, D.P. 7025; thence north-westerly along that boundary and south-westerly along the north-western boundary of the said Lot 1 to the north-eastern side of Ngawaka Road; thence north-westerly along that roadside to and north-easterly along the south-eastern side of a road coloured green on S.O. Plan 402 green, to and down the middle of the Tauraekaitai Stream, including the crossing of a public road, to a point in line with the eastern boundary of Block 34, Porangahau Crown Grant District; thence north-westerly and northerly to and along that boundary and its production to and down the middle of the Purimu Stream, including the crossing of the Wallingford-Hatuma road to a point in line with the north-eastern boundary of Lot 26, Deeds Plan 52A (now part Section 4, Block IX Motuotaraia Survey District); thence north-westerly along the south-eastern Deeds Plan 52A (now part Section 4, Block IX Motuotaraia Survey District); thence north-westerly to and along that boundary, to and north-easterly along the south-eastern boundaries of Lots 27, 23, and 21, Deeds Plan 52A, to the north-eastern corner of the last-named Lot 21; thence easterly along the northern boundaries of Lot 20, Deeds Plan 52A, and Lot 9, Deeds Plan 52, and the production of the last-named boundary to the western boundary of Lot 1, D.P. 2762; thence southerly along that boundary and easterly along the southern boundaries of that lot and Lot 1, D.P. 3797, to and south-easterly along the north-eastern boundaries of Lot 2, D.P. 3797, and Lot 2, D.P. 2350, to the westernmost corner of Section 19, Block XI, Motuotaraia Survey District; thence north-easterly along the north-western boundaries of that Section 19 and Sections 16, 14, and 15, all in that Block XI, and south-easterly along the north-eastern boundary of that Section 19 and Sections 16, 14, and 15, all in that Block XI, and south-easterly along the north-eastern boundary of the last-named Section 15, and its production to and south-westerly along the middle of Te Awa Road to a point in line with the north-eastern boundary of Section 17, Block XI, aforesaid; thence south-easterly to and along that boundary and south-westerly along the south-eastern boundary of that section to the south-western boundary of Tarawera Crown Grant District; thence south-easterly generally along the north-eastern boundary of Porangahau Crown Grant District, and along that boundary to and up the middle of the Huatokitoki Stream to the southern boundary of Lot 1, D.P. 8739; thence north-easterly and south-easterly generally along the north-western and north-eastern boundaries of that lot to the north-western side of Wallingford-Blackhead road; thence south-westerly along the south-western and south-eastern boundaries of the said Lot 1, to the south-western boundary of Block 2, Pourerere Crown Grant District; thence south-easterly along that boundary and the south-western boundaries of

Blocks 2A and 3, both Pourerere Crown Grant District, to the sea coast; thence south-westerly generally along the sea coast to and up the right bank of the Porangahau River to the point of commencement.
